AN ACT to amend the vehicle and traffic law and the navigation law, in increasing penalties for certain obstructed view for relation to drivers of motor vehicles and operators of vessels that result in injury or death

PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-THE BLY, DO ENACT AS FOLLOWS:

Section 1. Section 1213 of the vehicle and traffic law, as amended by chapter 621 of the laws of 1963, is amended to read as follows: 2

3 S 1213. Obstruction to driver's view or driving mechanism. (a) No person shall drive a motor vehicle when it is so loaded, or when there 4 5 in the front seat such number of persons as to obstruct the view of are the driver to the front or sides of the vehicle or as to interfere with б 7 driver's control over the driving mechanism of the vehicle. In no the event shall there be more than three persons in the front seat of any 8 vehicle, except where such seat has been constructed to accommodate more 9 10 than three persons and there is eighteen inches of seating capacity for each passenger or occupant in said front seat. 11

12 (b) No passenger in a vehicle shall ride in such a position as to 13 interfere with the driver's view ahead or to the sides, or to interfere with his OR HER control over the driving mechanism of the vehicle. 14

15 (C) A VIOLATION OF SUBDIVISION (A) OR (B) OF THIS SECTION THAT RESULTS 16 IN AN INJURY TO ANOTHER PERSON SHALL CONSTITUTE A CLASS A MISDEMEANOR. A 17 VIOLATION OF SUBDIVISION (A) OR (B) OF THIS SECTION THAT RESULTS IN THE DEATH OF ANOTHER PERSON SHALL CONSTITUTE A CLASS E FELONY. 18

19 The navigation law is amended by adding a new section 45-e to S 2. read as follows: 20

21 S 45-E. RECKLESS OPERATION OF A VESSEL; OBSTRUCTION TO OPERATOR'S VIEW 22 OR OPERATING MECHANISM. 1. NO PERSON SHALL OPERATE A MECHANICALLY PROPELLED VESSEL WHEN IT IS SO LOADED, OR WHEN THERE ARE SUCH NUMBER OF 23

1 PERSONS AS TO OBSTRUCT THE VIEW OF THE OPERATOR TO THE FRONT OR SIDES OF 2 THE VESSEL OR AS TO INTERFERE WITH THE OPERATOR'S CONTROL OVER THE OPER-3 ATING MECHANISM OF THE VESSEL.

4 2. NO PASSENGER IN A MECHANICALLY PROPELLED VESSEL SHALL RIDE IN SUCH 5 A POSITION AS TO INTERFERE WITH THE OPERATOR'S VIEW AHEAD OR TO THE 6 SIDES, OR TO INTERFERE WITH HIS OR HER CONTROL OVER THE OPERATING MECH-7 ANISM OF THE VESSEL.

8 3. A VIOLATION OF SUBDIVISION ONE OR TWO OF THIS SECTION THAT RESULTS 9 IN AN INJURY TO ANOTHER PERSON SHALL CONSTITUTE A CLASS A MISDEMEANOR. A 10 VIOLATION OF SUBDIVISION ONE OR TWO OF THIS SECTION THAT RESULTS IN THE 11 DEATH OF ANOTHER PERSON SHALL CONSTITUTE A CLASS E FELONY.

12 S 3. This act shall take effect on the first of November next succeed-13 ing the date on which it shall have become a law.
