AN ACT to amend chapter 118 of the laws of 1969, relating to a separate union free school district in the town of Greenburgh in the county of Westchester, in relation to clarifying the authority of the Greenburgh North Castle Union Free School District to lease certain properties located outside of its boundaries

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Chapter 118 of the laws of 1969, relating to a separate  
2     union free school district in the town of Greenburgh in the county of  
3     Westchester is amended by adding a new section 2-a to read as follows:  
4     S 2-A.    NOTWITHSTANDING ANY OTHER LAW, RULE, OR REGULATION TO THE  
5     CONTRARY, IN ADDITION TO THE POWERS GRANTED BY SECTION TWO OF THIS ACT,  
6     THE BOARD OF EDUCATION SHALL BE AUTHORIZED TO LEASE PROPERTIES LOCATED  
7     AT 108 SHONNARD PLACE IN THE CITY OF YONKERS, COUNTY OF WESTCHESTER, 623  
8     BLOOMING GROVE TURNPIKE IN THE TOWN OF NEW WINDSOR, COUNTY OF ORANGE,  
9     1700 OLD ORCHARD PLACE IN THE VILLAGE OF VALHALLA, COUNTY OF WESTCHES-  
10    TER, AND AT 24 MAPLE AVENUE IN THE CITY OF NEW ROCHELLE, COUNTY OF WEST-  
11    CHESTER FOR THE PURPOSE OF PROVIDING INSTRUCTION TO STUDENTS ENROLLED IN  
12    THE SCHOOL DISTRICT.

1     S 2. The actions of the board of education of the Greenburgh North  
2 Castle Union Free School District in entering a lease of properties  
3 located at 108 Shonnard Place in the city of Yonkers, county of West-  
4 chester, 623 Blooming Grove Turnpike in the town of New Windsor, county  
5 of Orange, 1700 Old Orchard Place in the village of Valhalla, county of  
6 Westchester, and at 24 Maple Avenue in the city of New Rochelle, county  
7 of Westchester prior to the effective date of this act are hereby rati-  
8 fied, validated and confirmed notwithstanding its location outside of  
9 the school district boundaries.  
10     S 3. This act shall take effect immediately.
