AN ACT to amend the executive law, in relation to the "state workforce fuel reduction and conservation act"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Short title. This act shall be known and may be cited as Section 1. the "state workforce fuel reduction and conservation act".

- S 2. The executive law is amended by adding a new section 201-b to read as follows:
- 201-B. STATE WORKFORCE FUEL REDUCTION AND CONSERVATION ACT. 1. THERE SHALL BE CREATED WITHIN THE OFFICE OF GENERAL SERVICES WORKFORCE FUEL REDUCTION AND CONSERVATION PROGRAM, WHICH SHALL HAVE THE PURPOSE OF DEVELOPING AND ASSISTING IN THE IMPLEMENTATION OF STRATEGIES TO REDUCE GASOLINE CONSUMPTION BY THE STATE'S MOTOR VEHICULAR FLEET, AND REDUCE GASOLINE CONSUMPTION THROUGH SOLO MOTOR VEHICLE TRIPS BETWEEN HOME AND THE WORKPLACE BY STATE EMPLOYEES AND STATE CONTRACTORS.
- 2. THE OFFICE OF GENERAL SERVICES, IN COORDINATION WITH THE GOVERNOR'S 13 OFFICE OF EMPLOYEE RELATIONS AND THE OFFICE FOR TECHNOLOGY, SHALL ISSUE TO THE GOVERNOR AND THE LEGISLATURE ON OR BEFORE NOVEMBER REPORT FIFTEENTH, TWO THOUSAND TEN, SETTING FORTH A SPECIFIC PLAN TO REDUCE THE NUMBER OF SOLO MOTOR VEHICLE TRIPS BETWEEN HOME AND THE WORKPLACE BY CONTRACTORS. SUCH PLAN SHALL INCLUDE, AT A 17 STATE EMPLOYEES AND STATE MINIMUM, PROPOSALS TO PROMOTE THE USE OF TRANSPORTATION OTHER 18 19 OCCUPANCY VEHICLES BY STATE EMPLOYEES TO AND FROM THE WORKPLACE,
- AND WHILE AT THE WORKPLACE: PROPOSALS FOR THE DEVELOPMENT, PROMOTION AND 20
- 21 IMPLEMENTATION OF A SOLO TRIP REDUCTION PROGRAM DESIGNED TO ENCOURAGE

STATE EMPLOYEES AND STATE CONTRACTORS TO USE AN ALTERNATIVE MODE OF COMMUTING SUCH AS CAR OR VAN POOLS, MASS TRANSIT, BIKING OR AGENCIES AND AUTHORITIES TO PERMIT ALTERNATIVE WORK AUTHORIZING STATE SCHEDULES OR TELECOMMUTING FOR ALL STATE EMPLOYEES AND CONTRACTORS WHERE 5 WOULD RESULT IN A REDUCTION IN HOME-WORKPLACE TRAVEL WITHOUT 6 DECREASING EMPLOYEE EFFICIENCY; AND A PROPOSAL TO REIMBURSE 7 EMPLOYEES AND CONTRACTORS FOR MASS TRANSIT COSTS WHERE DOING SO RESULTS 8 IN A NET REDUCTION IN SOLO MOTOR VEHICLE TRIPS.

- 3. THE OFFICE OF GENERAL SERVICES SHALL REVIEW THE SIZE OF THE STATE'S VEHICULAR FLEET, THE POLICIES GOVERNING THE USE OF SUCH FLEET AND THE ACTUAL USE OF SUCH FLEET, AND SHALL ISSUE TO THE GOVERNOR AND THE LEGISLATURE ON OR BEFORE NOVEMBER FIFTEENTH, TWO THOUSAND TEN, A SPECIFIC PLAN TO REDUCE THE USE OF SUCH FLEET IN ORDER TO REDUCE GASOLINE CONSUMPTION.
- S 3. Each state agency covered by section 201-b of the executive law, establishing a program to increase the average passenger occupancy per vehicle in commuting trips between home and the workplace, shall report to the office of general services on the status of such program within one hundred eighty days of the effective date of this act, and on the fifteenth day of January in each year thereafter.
- S 4. Each state agency that maintains its own vehicular fleet shall perform a fuel efficiency audit of such fleet and shall provide such audit to the office of general services within one hundred eighty days of the effective date of this act.
- S 5. The department of motor vehicles shall develop programs to educate the driving public on "smart driving," trip reduction and vehicle maintenance practices that are designed to maximize vehicle fuel efficiency. The department shall issue a report to the governor and the legislature on or before November 15, 2010 on the status of such program.
- 31 S 6. Nothing in this act shall impair any agreements which may be made 32 as a result of collective bargaining or other negotiations between the 33 state and its affected employee organizations.
 - S 7. This act shall take effect immediately.
