AN ACT to amend the town law, the public officers law and the village law, in relation to the residency requirement for certain part-time employees

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 23 of the town law is amended by adding a new 2 subdivision 23 to read as follows:

3 23. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION, 4 ANY TOWN IN THE STATE THAT HAS A POPULATION OF LESS THAN TWENTY THOUSAND 5 RESIDENTS ACCORDING TO THE TWO THOUSAND FEDERAL CENSUS MAY, AΤ ITS б OPTION, APPOINT A PERSON, WHO IS NOT AN ELECTOR OF SUCH TOWN, TO PERFORM 7 PART-TIME EMPLOYMENT POSITION; PROVIDED THAT THE DUTIES OF ANY THE PERSON PERFORMING THE FUNCTIONS OF A PART-TIME EMPLOYEE 8 IN ANY OTHER 9 TOWN SHALL BE AN ELECTOR OF SUCH TOWN UNLESS OTHERWISE PROVIDED BY LAW.

10 S 2. Section 3 of the public officers law is amended by adding a new 11 subdivision 56 to read as follows:

56. IN ANY TOWN IN THE STATE THAT HAS A POPULATION OF LESS THAN TWENTY 12 THOUSAND RESIDENTS ACCORDING TO THE TWO THOUSAND FEDERAL CENSUS OR ANY 13 14 VILLAGE THAT HAS A POPULATION OF LESS THAN TEN THOUSAND RESIDENTS ACCORDING TO THE TWO THOUSAND FEDERAL CENSUS, WHICH ELECTS TO BE SUBJECT 15 16 TO THE PROVISIONS OF THIS SUBDIVISION, THE PROVISIONS OF THIS SECTION PERSON TO BE A RESIDENT OF THE POLITICAL SUBDIVISION OR 17 REOUIRING A MUNICIPAL CORPORATION OF THE STATE FOR WHICH HE OR SHE SHALL 18 ΒE CHOSEN WITHIN WHICH HIS OR HER OFFICIAL FUNCTIONS ARE REQUIRED TO BE EXER-19 OR 20 CISED, SHALL NOT PREVENT A PERSON FROM HOLDING ANY PART-TIME EMPLOYMENT 21 POSITION IN THAT TOWN OR VILLAGE PROVIDED THAT SUCH PERSON RESIDES IN THE COUNTY IN WHICH SUCH TOWN OR VILLAGE IS LOCATED, OR AN 22 ADJOINING COUNTY WITHIN THE STATE OF NEW YORK. PROVIDED, FURTHER, THAT THE PERSON 23

4 S 3. Section 3-300 of the village law is amended by adding a new 5 subdivision 19 to read as follows:

19. NOTWITHSTANDING ANY PROVISION OF THIS CHAPTER OR ANY OTHER GENER-6 7 AL, SPECIAL, OR LOCAL LAW OR ORDINANCE, THE VILLAGE BOARD OF TRUSTEES OF 8 ANY INCORPORATED VILLAGE THAT HAS A POPULATION OF LESS THAN TEN THOUSAND RESIDENTS ACCORDING TO THE TWO THOUSAND FEDERAL CENSUS MAY, BY RESOL-9 10 UTION, PROVIDE THAT ANY PART-TIME EMPLOYMENT POSITION IN SUCH VILLAGE MAY BE HELD BY A PERSON WHO IS NOT A RESIDENT OF SUCH VILLAGE, PROVIDED 11 THAT SUCH PERSON RESIDES WITHIN THE COUNTY IN WHICH SUCH VILLAGE IS 12 LOCATED OR IN AN ADJOINING COUNTY WITHIN THE STATE OF NEW YORK. 13 14 S 4. This act shall take effect immediately.
