AN ACT to amend the penal law, in relation to increasing the penalties for criminal impersonation in the first and second degrees

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Section 190.25 of the penal law, the section heading, the 1 opening paragraph, subdivision 3 and the closing paragraph as amended by 2 3 chapter 27 of the laws of 1980, subdivision 4 as added by chapter 304 of 4 the laws of 2008, is amended to read as follows: 5

S 190.25 Criminal impersonation in the second degree.

A person is guilty of criminal impersonation in the second degree when he OR SHE:

1. Impersonates another and does an act in such assumed character with intent to obtain a benefit or to injure or defraud another; or

10 2. Pretends to be a representative of some person or organization and does an act in such pretended capacity with intent to obtain a benefit 11 12 or to injure or defraud another; or

3. (a) Pretends to be a public servant, or wears or displays without 13 authority any uniform, badge, insignia or facsimile thereof by which 14 15 such public servant is lawfully distinguished, or falsely expresses by OR HER words or actions that he OR SHE is a public servant or is 16 his acting with approval or authority of a public agency or department; and 17 so acts with intent to induce another to submit to such pretended 18 (b) official authority, to solicit funds or to otherwise cause another 19 to 20 act in reliance upon that pretense.

Pretends to be a police officer or a federal law enforcement offi-11 12 cer as enumerated in section 2.15 of the criminal procedure law, or 13 wears or displays without authority, any uniform, badge or other insigfacsimile thereof, by which such police officer or federal law 14 nia or 15 enforcement officer is lawfully distinguished or expresses by his or her words or actions that he or she is acting with the approval or authority 16 17 of any police department or acting as a federal law enforcement officer with the approval of any agency that employs federal law enforcement 18 19 officers as enumerated in section 2.15 of the criminal procedure law; 20 and 21 So acts with intent to induce another to submit to such pretended 2. 22 official authority or otherwise to act in reliance upon said pretense 23 and in the course of such pretense commits or attempts to commit a felo-24 ny; or 25 3. Pretending to be a duly licensed physician or other person author-26 ized to issue a prescription for any drug or any instrument or device used in the taking or administering of drugs for which a prescription is 27 28 required by law, communicates to a pharmacist an oral prescription which 29 required to be reduced to writing pursuant to section thirty-three is hundred thirty-two of the public health law. 30 Criminal impersonation in the first degree is a class [E] D felony. 31 32 S 3. This act shall take effect on the first of November next succeeding the date on which it shall have become a law. 33
