- AN ACT to amend the town law, in relation to authorizing the town board of the town of Hyde Park, in the county of Dutchess, to diminish the area of the Greenfields water district

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 202-c of the town law is amended by adding a new 2 subdivision 8 to read as follows:

3 8. NOTWITHSTANDING ANY OTHER PROVISION OF GENERAL, SPECIAL OR LOCAL 4 LAW, RULE, OR REGULATION TO THE CONTRARY, WHENEVER THE TOWN BOARD OF THE 5 TOWN OF HYDE PARK, DUTCHESS COUNTY, SHALL DETERMINE IT TO BE THE IN6 PUBLIC INTEREST, SAID TOWN BOARD MAY, UPON ITS OWN MOTION AND WITHOUT A 7 PETITION, BUT AFTER A PUBLIC HEARING HELD IN THE MANNER AND UPON THE NOTICE SPECIFIED IN SUBDIVISION ONE OF THIS SECTION, DIMINISH THE GREEN-8 9 WATER DISTRICT BY DELETING THEREFROM THE ONE HUNDRED NINETEEN FIELDS 10 TOWNHOUSE LOTS WHICH HAVE NOT SINCE THE FORMATION OF THE DISTRICT BEEN WATER INFRASTRUCTURE OR SERVICE AND PRESENTLY ARE 11 PROVIDED WITH ANY INCLUDED IN SAID DISTRICT. IN ADDITION, ANY ORDER ADOPTED BY 12 THE TOWN 13 BOARD PURSUANT TO THIS SUBDIVISION SHALL BE SUBJECT TO A PERMISSIVE REFERENDUM OF THE PROPERTY OWNERS IN THE GREENFIELDS 14 WATER DISTRICT 15 PURSUANT TO ARTICLE SEVEN OF THIS CHAPTER.

16 THE LANDS AUTHORIZED TO BE DELETED FROM THE GREENFIELDS WATER DISTRICT 17 IS DESCRIBED AS FOLLOWS:
