AN ACT to amend the general business law, in relation to debt management services; and to amend the banking law, in relation to the uniform debt-management services act; and repealing certain provisions of such laws relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The article heading of article 28-B of the general business 1 2 law, as added by chapter 1031 of the laws of 1965, is amended to read as 3 follows: 4

[BUDGET PLANNING] DEBT-MANAGEMENT SERVICES

S 2. Section 455 of the general business law is REPEALED and a new section 455 is added to read as follows:

7 S 455. DEFINITIONS. DEBT-MANAGEMENT SERVICES, AS USED IN THIS ARTICLE, 8 MEANS THE MAKING OF A CONTRACT BETWEEN A PERSON OR ENTITY ENGAGED IN THE 9 BUSINESS OF PROVIDING DEBT-MANAGEMENT SERVICES AS DEFINED IN ARTICLE TWELVE-C OF THE BANKING LAW. 10

S 3. Section 456 of the general business law, as amended by chapter 11 12 456 of the laws of 2006, is amended to read as follows:

[Budget planning] DEBT-MANAGEMENT prohibited. No person or 13 S 456. entity shall engage in the business of [budget planning] PROVIDING 14 DEBT-MANAGEMENT SERVICES as defined in section four hundred fifty-five 15 of this article, except as authorized in article twelve-C of the banking 16 17 law.

18 S 4. Article 12-C of the banking law is REPEALED and a new article 19 12-C is added to read as follows:

THE 14 SECTION IS TOLLED DURING ANY PERIOD DURING WHICH THE PROVIDER OR, IF 15 DIFFERENT, THE DEFENDANT HAS MATERIALLY AND WILLFULLY MISREPRESENTED 16 INFORMATION REQUIRED BY THIS ARTICLE TO BE DISCLOSED TO THE INDIVIDUAL, IF THE INFORMATION SO MISREPRESENTED IS MATERIAL TO THE ESTABLISHMENT OF 17 18 THE LIABILITY OF THE DEFENDANT UNDER THIS ARTICLE.

19 S 588-A. UNIFORMITY OF APPLICATION AND CONSTRUCTION. IN APPLYING AND 20 CONSTRUING THIS UNIFORM ACT, CONSIDERATION MUST BE GIVEN TO THE NEED TO 21 PROMOTE UNIFORMITY OF THE LAW WITH RESPECT TO ITS SUBJECT MATTER AMONG 22 STATES THAT ENACT IT.

23 S 588-B. RELATION TO ELECTRONIC SIGNATURES IN GLOBAL AND NATIONAL COMMERCE ACT. THIS ARTICLE MODIFIES, LIMITS, AND SUPERSEDES THE FEDERAL 24 25 ELECTRONIC SIGNATURES IN GLOBAL AND NATIONAL COMMERCE ACT (15 U.S.C. SECTION 26 7001 ET SEQ.) BUT DOES NOT MODIFY, LIMIT, OR SUPERSEDE SECTION 27 101(C) OF THAT ACT (15 U.S.C. SECTION 7001(C)) OR AUTHORIZE ELECTRONIC 28 DELIVERY OF ANY OF THE NOTICES DESCRIBED IN SECTION 103(B) OF THAT ACT 29 (15 U.S.C. SECTION 7003(B)).

30 TRANSITIONAL PROVISIONS; APPLICATION TO EXISTING S 588-C. TRANS-ACTIONS. TRANSACTIONS ENTERED INTO BEFORE THIS ARTICLE TAKES EFFECT AND 31 32 THE RIGHTS, DUTIES, AND INTERESTS RESULTING FROM THEM MAY BE COMPLETED, TERMINATED, OR ENFORCED AS REQUIRED OR PERMITTED BY A 33 LAW AMENDED, REPEALED, OR MODIFIED BY THIS ARTICLE AS THOUGH THE AMENDMENT, REPEAL, 34 35 OR MODIFICATION HAD NOT OCCURRED.

S 5. Severability. If any clause, sentence, paragraph, section or part 36 37 of this act shall be adjudged by any court of competent jurisdiction to invalid and after exhaustion of all further judicial review, the 38 be 39 judgment shall not affect, impair or invalidate the remainder thereof, 40 shall be confined in its operation to the clause, sentence, parabut graph, section or part of this act directly involved in the controversy 41 in which the judgment shall have been rendered. 42

S 6. This act shall take effect one year after it shall have become a law; provided, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
