AN ACT to amend the education law, in relation to creating "the school district finance security task force"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Short title. This act shall be known and may be cited as "the school district finance security task force act".

2. The education law is amended by adding a new article 9-A to read as follows:

- 10 S 430. SCHOOL DISTRICT FINANCE SECURITY TASK FORCE. 1. THERE IS HEREBY 11 CREATED THE SCHOOL DISTRICT FINANCE SECURITY TASK FORCE WHICH SHALL THE SECURITY OF SCHOOL DISTRICT BANK AND OTHER FINANCIAL 12 INVESTIGATE 13 ACCOUNTS.
