AN ACT to amend the vehicle and traffic law, in relation to certifications of disability for severely disabled persons to obtain certain motor vehicle registrations, plates and permits

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The opening paragraph and paragraph (c) of subdivision 4 and paragraph (b) of subdivision 5 of section 404-a of the vehicle and traffic law, as amended by chapter 228 of the laws of 2008, are amended and a new subdivision 4-b is added to read as follows:

The commissioner shall issue sets of plates to such person in accord-5 б ance with subdivision two of this section with proof of such disability 7 of such person or such members of his family certified by a physician, physician assistant or nurse practitioner, to the extent authorized by 8 9 including the education law, and consistent with any applicable law, 10 written practice agreement, or podiatrist pursuant to subdivision four-a of this section OR OPTOMETRIST PURSUANT TO SUBDIVISION FOUR-B OF 11 THIS SECTION, to the satisfaction of the commissioner who is empowered to 12 13 carry out the effects of this section by formulating rules and regu-14 lations.

15 (c) Has a physical or mental impairment or condition which is other 16 than those specified above, but is of such nature as to impose unusual 17 hardship in utilization of public transportation facilities and such 18 condition is certified by a physician, physician assistant or nurse 19 practitioner, to the extent authorized by law, including the education 20 law, and consistent with any applicable written practice agreement, duly licensed to practice medicine in this state, or, pursuant to subdivision 21 four-a of this section, a podiatrist duly licensed to practice podiatry 22 PURSUANT TO SUBDIVISION FOUR-B OF THIS SECTION, AN 23 in this state OR, OPTOMETRIST DULY LICENSED 24 TO PRACTICE OPTOMETRY IN THIS STATE, as 25 constituting an equal degree of disability (specifying the particular 26 condition) so as to prevent such person from getting around without great difficulty in accordance with subdivision two of this section; or 27

1 The commissioner may require the applicant for registration to (b) 2 furnish such proof of his disability or such proof of disability of such 3 members of his family from a physician, physician assistant or nurse practitioner, to the extent authorized by law, including the education 4 and consistent with any applicable written practice agreement, or 5 law, 6 podiatrist pursuant to subdivision four-a of this section OR OPTOMETRIST 7 PURSUANT TO SUBDIVISION FOUR-B OF THIS SECTION, as the commissioner 8 deems necessary either for initial registration or renewal thereof; provided, however, that a handicapped or disabled permit issued by a 9 10 municipality to such applicant pursuant to section twelve hundred three-a of this chapter shall be deemed sufficient proof 11 of disability for purposes of this paragraph. 12

4-B. CERTIFICATION OF DISABILITY BY AN OPTOMETRIST. AN OPTOMETRIST
DULY LICENSED TO PRACTICE OPTOMETRY IN THIS STATE MAY CERTIFY ONLY THOSE
CONDITIONS WHICH HE OR SHE TREATS IN THE COURSE OF THE PRACTICE OF OPTOMETRY, AS DEFINED IN SECTION SEVENTY-ONE HUNDRED ONE OF THE EDUCATION
LAW.

18 S 2. Paragraph (i) of subdivision 1 and subdivision 3 of section 19 1203-a of the vehicle and traffic law, paragraph (i) of subdivision 1 as 20 amended by chapter 180 of the laws of 1996 and subdivision 3 as amended 21 by chapter 220 of the laws of 1984, are amended to read as follows:

22 (i) any resident of New York state who is a severely disabled person, 23 as defined in subdivision three of section four hundred four-a of this chapter, upon application of such person or such person's parent or 24 25 guardian, provided, however, that an issuing agent shall issue permits 26 only to residents of the city, town or village in which such issuing located, except that, an issuing agent, in his or her 27 agent is 28 may issue a permit to a severely disabled person who is not discretion, 29 a resident of the city, town, or village in which such issuing agent is located where such person resides in a city, town, or village in which 30 the governing body has not appointed an issuing agent; and an issuing 31 32 agent, in his or her discretion, may issue a temporary special vehicle identification parking permit, as authorized by subdivision three of 33 this section, to a person who is temporarily unable to ambulate without 34 35 the aid of an assisting device, as certified by a physician OR AN OPTO-METRIST PURSUANT TO SUBDIVISION FOUR-B OF SECTION FOUR HUNDRED FOUR-A OF 36 37 THIS CHAPTER, who resides in a city, town, or village in which the issu-38 ing agent does not issue temporary special vehicle identification park-39 ing permits, or who is not a resident of the United States and is tempo-40 rarily visiting the state; or

Notwithstanding any provision of this chapter to the contrary, 41 any municipality may issue a temporary special vehicle identification park-42 43 ing permit to any person who is temporarily unable to ambulate without 44 aid of an assisting device, as certified by a physician OR AN OPTOthe 45 METRIST PURSUANT TO SUBDIVISION FOUR-B OF SECTION FOUR HUNDRED FOUR-A OF Such temporary special vehicle identification parking THIS CHAPTER. 46 47 shall be valid for not more than six months and shall be recogpermit 48 nized statewide.
