AN ACT to authorize the village of Dexter, town of Brownville, county of Jefferson to discontinue the use of certain village lands as parkland and to sell and convey such lands

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The village of Dexter, town of Brownville, Jefferson coun-
2 ty, is hereby authorized to discontinue as parklands and alienate, sell
3 and convey the lands described in section two of this act for fair
4 market value and in exchange therefor, dedicate as parklands new land or
5 make improvements to existing park and recreational facilities, as
6 necessary, to equal such fair market value.
7 S 2. The lands to be discontinued as parklands and alienated, sold and
8 conveyed are described as follows:
9 All the tract or certain parcel of land located in the village of
10 Dexter, town of Brownville, Jefferson county situated to the south of
11 Water Street and more particularly described as follows:
12 Beginning at a 1/2 inch iron pipe with stamped red survey cap set
13 (January 2005) at the southwest corner of a 0.303 acre parcel of land
14 described in a deed from Harry L. Dence to Carolyn A. Symonds dated
15 January 27, 2005 and recorded in the Jefferson county clerk's office on
16 February 11, 2005 as instrument no. 2005-2216, said point of beginning
17 is also situated S.16°20'05"W., along the west line of the above refer-
18 enced 0.303 acre Symonds parcel, a distance of 132.00 feet from a 1/2
19 inch iron rod with stamped red survey cap set (January 2005) in a
20 concrete drive in the southerly margin of Water Street; Thence from said
21 point of beginning S.73°34'00"E., along a southerly line of the above
22 referenced 0.303 acre Symonds parcel, a distance of 50.00 feet to a 1/2
23 inch pipe with stamped red survey cap set (January 2005) at a corner
24 thereof; Thence N.16°20'05"E., continuing along a line of the above
25 referenced 0.303 acre Symonds parcel, a total distance of 22.00 feet to
26 a 1/2 inch iron pipe with stamped red survey cap set (January 2005) at a
27 corner of said 0.303 acre and passing on line at 8.16 feet a 3/4 inch

1 iron pipe found; Thence S.73°39'55"E., continuing along a southerly line
2 of the above referenced 0.303 acre Symonds parcel, a distance of 60.00
3 feet to a 1/2 inch iron pipe with stamped red survey cap set (January
4 2005) at the southeast corner of said 0.303 acres, said iron pipe is
5 situate S. 16°20'05"W., along the east line of the above referenced
6 0.303 acre Symonds parcel, a distance of 110.00 feet from a 1/2 inch
7 iron rod set in blacktop (flush) in the southerly margin of Water
8 Street; Thence S.16°20'05"W., along the southerly prolongation of the
9 east line of the above referenced 0.303 acre Symonds parcel, a distance
10 of approximately 40 feet to the shoreline of the Black River; Thence in
11 a general westerly direction, along the shoreline of the Black River as
12 it bends and turns, to a point; Thence, N.16°20'05"E., along the south-
13 erly prolongation of the west line of the above referenced 0.303 acre
14 Symonds parcel, a distance of approximately 36 feet to the point of
15 beginning

16 S 3. In the event that the replacement village parklands to be dedi-
17 cated in section two of this act are not equal to twice the size of the
18 lands to be alienated in substitution of said lands, or are not equal to
19 or greater than the fair market value of the lands to be alienated in
20 section two of this act, the village of Dexter shall dedicate additional
21 village-owned lands for parkland and/or cause funds to be made available
22 for capital improvements to its existing park and recreational facili-
23 ties, as necessary, to equal such fair market value.

24 S 4. The discontinuance and conveyance of parkland authorized by the
25 provisions of this act shall not occur until the village of Dexter has
26 complied with any federal requirements pertaining to the alienation or
27 conversation of parklands, including satisfying the secretary of the
28 interior that the conversion complies with all conditions which the
29 secretary of interior deems necessary to assure the substitution of
30 other lands shall be equivalent in fair market value and recreational
31 usefulness to the lands being alienated or converted.

32 S 5. This act shall take effect immediately.
