AN ACT to amend the social services law and the correction law, in relation to the placement of homeless sex offenders in Suffolk county

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     Section 1. Section 136 of the social services law is amended by adding  
2     a new subdivision 6 to read as follows:  
3     6. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISION TWO OF THIS SECTION,  
4     IN THE EVENT THAT THE COUNTY COMMISSIONER OF SOCIAL SERVICES OF THE  
5     COUNTY OF SUFFOLK MOVES OR PLACES A HOMELESS PERSON, WHO SUCH COMMIS-  
6     SIONER KNOWS TO BE A SEX OFFENDER REQUIRED TO REGISTER PURSUANT TO ARTI-  
7     CLE SIX-C OF THE CORRECTION LAW, IN ANY FORM OF TEMPORARY EMERGENCY  
8     HOUSING, INCLUDING A MOBILE HOME, TRAILER OR SIMILAR STRUCTURE, SUCH  
9     COMMISSIONER SHALL, WITHIN TWENTY-FOUR HOURS, NOTIFY THE DIVISION OF  
10    CRIMINAL JUSTICE SERVICES AND THE LOCAL LAW ENFORCEMENT AGENCY IN THE  
11    VILLAGE, TOWN OR CITY WITHIN SUCH COUNTY WHERE SUCH HOUSING IS LOCATED  
12    AND PROVIDE THE NAME AND ADDRESS OF THE SEX OFFENDER BEING PLACED. SUCH  
13    NOTICE SHALL SATISFY THE REQUIREMENTS OF SUBDIVISION FOUR OF SECTION ONE  
14    HUNDRED SIXTY-EIGHT-F OF THE CORRECTION LAW.  
15    S 2. Section 168-f of the correction law is amended by adding a new  
16    subdivision 7 to read as follows:  
17    7. IN THE EVENT THAT THE COUNTY COMMISSIONER OF SOCIAL SERVICES OF THE  
18    COUNTY OF SUFFOLK MOVES OR PLACES A HOMELESS PERSON, WHOM SUCH COMMIS-  
19    SIONER KNOWS TO BE A SEX OFFENDER REQUIRED TO REGISTER PURSUANT TO THIS  
20    ARTICLE, IN ANY FORM OF TEMPORARY EMERGENCY HOUSING, INCLUDING A MOBILE  
21    HOME, TRAILER OR SIMILAR STRUCTURE, SUCH COMMISSIONER SHALL, WITHIN  
22    TWENTY-FOUR HOURS, NOTIFY THE DIVISION AND THE LOCAL LAW ENFORCEMENT  
23    AGENCY IN THE VILLAGE, TOWN OR CITY WITHIN SUCH COUNTY WHERE SUCH HOUS-  
24    ING IS LOCATED AND PROVIDE THE NAME AND ADDRESS OF THE SEX OFFENDER  
25    BEING PLACED. SUCH NOTICE SHALL SATISFY THE REQUIREMENTS OF SUBDIVISION  
26    FOUR OF THIS SECTION.  
27    S 3. This act shall take effect immediately.
