AN ACT to amend the tax law and the state finance law, in relation to authorizing a tax check-off for gifts to food banks

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The tax law is amended by adding a new section 625-a to 2 read as follows:
- 3 S 625-A. GIFTS TO FOOD BANKS. EFFECTIVE FOR ANY TAXABLE YEAR COMMENC-ING ON OR AFTER JANUARY FIRST, TWO THOUSAND TEN, AN INDIVIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE STATE GIFTS TO FOOD FUND FOR FINANCIAL SUPPORT FOR REGIONAL FOOD BANKS. SUCH CONTRIBUTION 7 SHALL BE IN ANY WHOLE DOLLAR AMOUNT AND SHALL NOT REDUCE THE AMOUNT 8 TAX OWED BY SUCH INDIVIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE PERSONAL INCOME TAX RETURN TO ENABLE A TAXPAYER TO MAKE 9 10 CONTRIBUTION. NOTWITHSTANDING ANY OTHER PROVISION OF LAW ALL REVENUES COLLECTED PURSUANT TO THIS SECTION SHALL BE CREDITED TO THEGIFTS 11 BANKS FUND AND USED ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION 12 13 EIGHTY-TWO OF THE STATE FINANCE LAW.
- 14 S 2. The state finance law is amended by adding a new section 82 to 15 read as follows:
- 16 GIFTS TO FOOD BANKS FUND. THE GIFTS TO FOOD BANKS FUND SHALL 17 CONSIST OF ALL MONEYS RECEIVED BY THE DEPARTMENT OF TAXATION AND FINANCE FROM GIFTS TO FOOD BANKS PURSUANT TO SECTION SIX HUNDRED TWENTY-FIVE-A 18 SUCH MONEYS, AFTER APPROPRIATION BY THE LEGISLATURE, 19 TAX LAW. SHALL BE AVAILABLE TO THE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE 20 FOR THE DISTRIBUTION OF GRANTS TO REGIONAL FOOD BANKS ORGANIZED TO SERVE 21 22 SPECIFIC REGIONS THAT GENERALLY COLLECT AND REDISTRIBUTE FOOD DONATIONS
- 23 TO ORGANIZATIONS SERVING PERSONS IN NEED. THE COMMISSIONER OF TEMPORARY 24 AND DISABILITY ASSISTANCE IS HEREBY AUTHORIZED AND DIRECTED TO PROMUL-
- 25 GATE RULES AND REGULATIONS NECESSARY FOR THE DISTRIBUTION OF SUCH
- 26 GRANTS.
- 27 S 3. This act shall take effect immediately.
