- AN ACT authorizing the county of Saratoga to discontinue for reforestation purposes the use of certain lands and to convey such lands

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Notwithstanding section 219 of the county 1 law to the 2 contrary, the county of Saratoga, acting through its county board of 3 supervisors, is hereby authorized to discontinue the use of lands 4 described in section two of this act acquired for reforestation purposes 5 and to enter into a contract to convey its interest in the real property 6 described in section two of this act, to the town of Moreau to as construct a court and public safety facility and a future town hall. 7 8 The authorization provided in this section shall be effective only upon 9 the reacquisition by the county of Saratoga of the parcel as described section three of this act, which is currently vacant property by the 10 in 11 public for recreational or reforestation purposes.

12 S 2. The real property authorized to be conveyed by the county of 13 Saratoga pursuant to section one of this act shall be bounded and 14 described as follows:

15 ALL THAT TRACT OR PARCEL OF LAND situate north of NYS Rte. 197, 16 Reynolds Road, Town of Moreau, Saratoga County, State of New York and 17 being more particularly bounded and described as follows:

Beginning at a point at the southeast corner of the herein described parcel and also being the northeast corner of other lands of the Town of Moreau (formerly Jehovah's Witnesses Lands) and also being on the west boundary of the White Birch MHC, LLC (L. 1562 P. 189), thence

19 The authorization provided in section one of this act shall be S 3. 20 effective only upon the condition that on or before the alienation and 21 conveyance of lands described in section two of this act, the county of 22 Saratoga shall acquire and dedicate real property for reforestation 23 purposes, of equal or greater fair market value to the lands being 24 alienated. In the event that the lands to be acquired by the county of 25 Saratoga for reforestation purposes pursuant to this act are not equal 26 to or greater than the fair market value of the lands to be alienated by 27 the county of Saratoga, the county shall dedicate the difference between 28 the fair market value of the lands to be alienated and the fair market 29 value of the lands to be acquired; for the acquisition of additional 30 lands for reforestation purposes. The additional real property to be 31 acquired and dedicated for reforestation purposes, being more partic-32 ularly bound and described as follows:

ALL that tract or parcel of land situate south of Butler Road and west 33 of Redmond Road, Town of Moreau, Saratoga County, State of New York and 34 35 being more particularly bounded and described as follows:
