- AN ACT to amend the correction law, in relation to providing certain information regarding level one sex offenders to the offices of local village, town, city, county or state law enforcement agencies

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 168-q of the correction law is 2 renumbered subdivision 3 and a new subdivision 2 is added to read as 3 follows:

4 2. THE DIVISION SHALL MAINTAIN A SEPARATE SUBDIRECTORY OF LEVEL ONE 5 SEX OFFENDERS. THE SUBDIRECTORY SHALL INCLUDE THE EXACT ADDRESS, ADDRESS OF THE OFFENDER'S PLACE OF EMPLOYMENT AND PHOTOGRAPH OF THE SEX OFFENDER 6 7 ALONG WITH THE FOLLOWING INFORMATION, IF AVAILABLE: NAME, PHYSICAL 8 DESCRIPTION, AGE AND DISTINCTIVE MARKINGS. BACKGROUND INFORMATION INCLUDING THE SEX OFFENDER'S CRIME OF CONVICTION, MODUS OF OPERATION, 9 10 TYPE OF VICTIM TARGETED, THE NAME AND ADDRESS OF ANY INSTITUTION OF EDUCATION AT WHICH THE SEX OFFENDER IS ENROLLED, ATTENDS, IS 11 HIGHER 12 EMPLOYED OR RESIDES AND A DESCRIPTION OF SPECIAL CONDITIONS IMPOSED ON THE SEX OFFENDER SHALL ALSO BE INCLUDED. THE SUBDIRECTORY SHALL HAVE SEX 13 OFFENDER LISTINGS CATEGORIZED BY COUNTY AND ZIP CODE. A COPY OF THE 14 15 SUBDIRECTORY SHALL ANNUALLY BE DISTRIBUTED ΤO THEOFFICES OF LOCAL VILLAGE, TOWN, CITY, COUNTY OR STATE LAW ENFORCEMENT AGENCIES FOR ANY 16 17 LAW ENFORCEMENT PURPOSE AND SHALL NOT BE MADE ACCESSIBLE TO THE PUBLIC. DIVISION SHALL DISTRIBUTE MONTHLY UPDATES TO THE OFFICES OF LOCAL 18 THE VILLAGE, TOWN, CITY, STATE LAW ENFORCEMENT 19 COUNTY OR AGENCIES FOR PURPOSES OF PUBLIC ACCESS. SUCH DEPARTMENTS SHALL REQUIRE THAT A PERSON 20 21 IN WRITING PROVIDE THEIR NAME AND ADDRESS PRIOR TO VIEWING THE SUBDIREC-22 TORY. THE SUBDIRECTORY PROVIDED FOR IN THIS SUBDIVISION SHALL BE UPDATED 23 MONTHLY TO MAINTAIN ITS EFFICIENCY AND USEFULNESS AND SHALL BE COMPUTER
