- AN ACT to amend the agriculture and markets law, in relation to training, examination and certification of dog control officers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The agriculture and markets law is amended by adding a new 2 section 114-a to read as follows:

3 S 114-A. TRAINING AND CERTIFICATION OF DOG CONTROL OFFICERS. 1. THE 4 DEPARTMENT SHALL DEVELOP A TRAINING, EXAMINATION AND CERTIFICATION 5 PROGRAM FOR DOG CONTROL OFFICERS, POLICE OFFICERS AND PEACE OFFICERS WHO 6 DEAL WITH ANIMAL CONTROL OR ANIMAL ABUSE ISSUES.

7 EXCEPT AS PROVIDED IN PARAGRAPH (B) OF THIS SUBDIVISION, ANY 2. (A) 8 PERSON APPOINTED AS A DOG CONTROL OFFICER SHALL, WHERE REQUIRED BY THE 9 GOVERNING BODY OF ANY POLITICAL SUBDIVISION, COMPLETE A COURSE OF TRAIN-THE DEPARTMENT AND SHALL TAKE AND PASS AN EXAMINATION 10 ING APPROVED ΒY GIVEN BY THE DEPARTMENT. ANY PERSON CURRENTLY EMPLOYED AS A DOG 11 CONTROL WHERE REQUIRED BY THE GOVERNING BODY OF ANY POLITICAL 12 OFFICER SHALL, SUBDIVISION, COMPLETE THE TRAINING AND TAKE AND PASS THE EXAMINATION NO 13 14 THAN DECEMBER FIRST, TWO THOUSAND FOURTEEN. THE DEPARTMENT SHALL: (A) DETERMINE THE FORMAT OF THE TRAINING AND 26 CERTIFICATION EXAMINATIONS, INCLUDING AN INTERNET-BASED FORMAT IF THE 27 DEPARTMENT DEEMS SUCH TO BE APPROPRIATE; 28 (B) ESTABLISH THE SCHEDULE FOR OFFERING TRAINING AND EXAMINATIONS; 29 (C) ESTABLISH SUCH FEES AS THE DEPARTMENT DEEMS NECESSARY FOR TRAIN-ING, ADMISSION TO THE EXAMINATION, RE-EXAMINATION AND CERTIFICATION; AND 30 (D) PROMULGATE RULES, REGULATIONS AND STANDARDS REGARDING THE APPLICA-31 32 TION OF THE TRAINING AND CERTIFICATION TOWARD RECERTIFICATION OR CONTIN-33 UING EDUCATION REOUIREMENTS. 34 S 2. This act shall take effect July 1, 2014, provided that, effective immediately, the addition, amendment and/or repeal of any rule or regu-35 lation necessary for the implementation of this act on its effective 36 37 date are authorized to be made on or before such effective date.
