AN ACT to amend the real property law, in relation to requiring the disclosure, upon the sale or lease of residential real property, of the availability of certain sex offender information

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The real property law is amended by adding two new sections 2 220-a and 242-a to read as follows:

3 S 220-A. DISCLOSURE OF THE AVAILABILITY OF SEX OFFENDER INFORMATION. 4 1. EVERY LEASE AND RENTAL AGREEMENT OF RESIDENTIAL REAL PROPERTY SHALL 5 CONTAIN IN NOT LESS THAN EIGHT POINT TYPE, THE FOLLOWING NOTICE:

6 NOTICE: THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES MAIN-7 AND DISTRIBUTES A SUBDIRECTORY, WHICH IS A BOOK THAT PROVIDES THE TAINS 8 LOCATION OF HIGH RISK SEX OFFENDERS REOUIRED TO REGISTER PURSUANT ΤO ARTICLE 6-C OF THE CORRECTION LAW, THE SEX OFFENDER REGISTRATION ACT, TO 9 OFFICES OF LOCAL VILLAGE, TOWN, CITY, AND COUNTY POLICE DEPARTMENTS 10 THE AND STATE LAW ENFORCEMENT AGENCIES FOR THE PURPOSE OF PUBLIC ACCESS. 11 PLEASE CONTACT YOUR LOCAL LAW ENFORCEMENT AGENCY FOR FURTHER INFORMATION 12 13 ON HOW TO ACCESS AND VIEW THE SUBDIRECTORY OF HIGH RISK SEX OFFENDERS. THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES ALSO OPERATES 14 FOR PUBLIC ACCESS A SPECIAL "900" TELEPHONE NUMBER THROUGH WHICH CALLERS 15 16 MAY VERIFY THE REGISTRATION OF A NAMED INDIVIDUAL. CALLERS MUST HAVE 17 SPECIFIC INFORMATION WHICH WILL ACHIEVE POSITIVE IDENTIFICATION SUCH AS 18 EXACT ADDRESS, DRIVER'S LICENSE NUMBER OR BIRTH DATE. IN ADDITION, AN THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE 19 SERVICES MAINTAINS A 20 WEBSITE PROVIDING INFORMATION, INCLUDING THE NAMES AND ADDRESSES, 21 REGARDING CERTAIN SEX OFFENDERS.

22 2. SUBJECT TO THE PROVISIONS OF SUBDIVISION FOUR OF THIS SECTION, UPON 23 DELIVERY OF THE NOTICE REQUIRED PURSUANT TO SUBDIVISION ONE OF THIS 24 SECTION TO THE LESSEE OF THE RESIDENTIAL REAL PROPERTY, NEITHER THE

LESSOR NOR ANY AGENT OF THE LESSOR SHALL BE REOUIRED TO PROVIDE INFORMA-1 TION IN ADDITION TO THAT CONTAINED IN THE NOTICE REGARDING THE AVAIL-2 3 THE SUBDIRECTORY, THE SPECIAL "900" NUMBER OR THE WEBSITE. ABILITY OF 4 THE INFORMATION IN SUCH NOTICE SHALL BE DEEMED TO BE ADEQUATE TO INFORM 5 THE LESSEE ABOUT THE EXISTENCE OF A STATEWIDE SUBDIRECTORY OF THE 6 LOCATIONS OF HIGH RISK SEX OFFENDERS AND INFORMATION FROM THE SUBDIREC-7 TORY REGARDING THOSE LOCATIONS. WHERE THE LESSEE RECEIVES THE NOTICE CONTAINED IN SUBDIVISION ONE 9 3. 10 OF THIS SECTION AT OR BEFORE THE TIME OF A WRITTEN OFFER OF A LEASE OR RENTAL AGREEMENT FOR THE LEASE OF RESIDENTIAL REAL PROPERTY, ANY PERSON 11 12 WHO IS LICENSED AS A REAL ESTATE BROKER, ASSOCIATE REAL ESTATE BROKER, 13 REAL ESTATE SALESPERSON UNDER SECTION FOUR HUNDRED FORTY-A OF THIS OR 14 CHAPTER AND WHO IS ACTING IN A FIDUCIARY CAPACITY FOR EITHER A LESSOR OR A LESSEE OF RESIDENTIAL REAL PROPERTY SHALL NOT BE REQUIRED TO PROVIDE 15 16 FURTHER INFORMATION TO THE LESSEE OF THE RESIDENTIAL REAL PROPERTY ANY REGARDING INFORMATION RELATING TO OR THE LOCATION OF SEX OFFENDERS. 17

4. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISIONS ONE AND TWO OF THIS
SECTION, NOTHING IN THIS SECTION SHALL ALTER ANY EXISTING DUTY OF THE
LESSOR OR ANY AGENT OF SUCH LESSOR UNDER ANY OTHER PROVISION OF LAW.

S 242-A. DISCLOSURE OF THE AVAILABILITY OF SEX OFFENDER INFORMATION.
I. EVERY CONTRACT FOR THE PURCHASE OF RESIDENTIAL REAL PROPERTY,
COMPRISING ONE TO FOUR DWELLING UNITS, SHALL CONTAIN IN NOT LESS THAN
EIGHT POINT TYPE, THE FOLLOWING NOTICE:

CALLERS MUST HAVE MAY SPECIFIC INFORMATION WHICH WILL ACHIEVE POSITIVE IDENTIFICATION SUCH AS 36 37 AN EXACT ADDRESS, DRIVER'S LICENSE NUMBER OR BIRTH DATE. IN ADDITION, 38 THE NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES MAINTAINS A 39 WEBSITE PROVIDING INFORMATION, INCLUDING THE NAMES AND ADDRESSES, 40 REGARDING CERTAIN SEX OFFENDERS.

SUBJECT TO THE PROVISIONS OF SUBDIVISION FOUR OF THIS SECTION, UPON 41 DELIVERY OF THE NOTICE REQUIRED PURSUANT TO SUBDIVISION ONE OF 42 THIS 43 SECTION TO THE BUYER OF THE RESIDENTIAL REAL PROPERTY, NEITHER THE SELL-44 ER NOR ANY AGENT OF THE SELLER SHALL BE REQUIRED TO PROVIDE INFORMATION 45 IN ADDITION TO THAT CONTAINED IN THE NOTICE REGARDING THE AVAILABILITY THE SUBDIRECTORY, THE SPECIAL "900" NUMBER OR THE WEBSITE. 46 THE OF 47 INFORMATION IN SUCH NOTICE SHALL BE DEEMED TO BE ADEQUATE TO INFORM THE 48 BUYER ABOUT THE EXISTENCE OF A STATEWIDE SUBDIRECTORY OF THE LOCATIONS 49 OF HIGH RISK SEX OFFENDERS AND INFORMATION FROM THE SUBDIRECTORY REGARD-50 ING THOSE LOCATIONS. WHERE THE BUYER RECEIVES THE NOTICE CONTAINED IN SUBDIVISION ONE OF 53 THIS SECTION AT OR BEFORE THE TIME OF THE MAKING OF A WRITTEN OFFER FOR 54 THE PURCHASE OF RESIDENTIAL REAL PROPERTY, ANY PERSON WHO IS LICENSED AS 55 A REAL ESTATE BROKER, ASSOCIATE REAL ESTATE BROKER, OR REAL ESTATE 56 SALESPERSON UNDER SECTION FOUR HUNDRED FORTY-A OF THIS CHAPTER AND WHO

1 IS ACTING IN A FIDUCIARY CAPACITY FOR EITHER A BUYER OR A SELLER OF 2 RESIDENTIAL REAL PROPERTY SHALL NOT BE REQUIRED TO PROVIDE ANY FURTHER 3 INFORMATION TO THE BUYER OF THE RESIDENTIAL REAL PROPERTY REGARDING 4 INFORMATION RELATING TO OR THE LOCATION OF SEX OFFENDERS.

5 4. NOTWITHSTANDING THE PROVISIONS OF SUBDIVISIONS ONE AND TWO OF THIS 6 SECTION, NOTHING IN THIS SECTION SHALL ALTER ANY EXISTING DUTY OF THE 7 SELLER OR ANY AGENT OF SUCH SELLER UNDER ANY OTHER PROVISION OF LAW.

8 S 2. This act shall take effect on the ninetieth day after it shall 9 have become a law and shall apply to contracts and agreements entered 10 into on or after such date.
