- AN ACT to amend the executive law, in relation to unlawful discriminatory practices in housing based on lawful source of income

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 292 of the executive law is amended by adding a new 2 subdivision 35 to read as follows:

3 35. THE TERM "LAWFUL SOURCE OF INCOME" SHALL INCLUDE, BUT NOT BE 4 LIMITED TO, THE FEDERAL HOUSING SUBSIDY KNOWN AS "SECTION EIGHT".

5 S 2. Paragraphs (a), (b), (c) and (c-1) of subdivision 2-a of section 6 296 of the executive law, paragraphs (a), (b) and (c) as amended and 7 paragraph (c-1) as added by chapter 106 of the laws of 2003, are amended 8 to read as follows:

9 (a) To refuse to sell, rent or lease or otherwise to deny to or with-10 hold from any person or group of persons such housing accommodations 11 because of the race, creed, color, disability, national origin, sexual 12 orientation, military status, age, sex, marital status, LAWFUL SOURCE OF 13 INCOME or familial status of such person or persons, or to represent 14 that any housing accommodation or land is not available for inspection, 15 sale, rental or lease when in fact it is so available.

16 (b) To discriminate against any person because of his or her race, 17 creed, color, disability, national origin, sexual orientation, military 18 status, age, sex, marital status, LAWFUL SOURCE OF INCOME or familial 19 status in the terms, conditions or privileges of any publicly-assisted 20 housing accommodations or in the furnishing of facilities or services in 21 connection therewith.

22 (c) To cause to be made any written or oral inquiry or record concern-23 ing the race, creed, color, disability, national origin, sexual orien-24 tation, membership in the reserve armed forces of the United States or

1 in the organized militia of the state, age, sex, marital status, LAWFUL 2 SOURCE OF INCOME or familial status of a person seeking to rent or lease 3 any publicly-assisted housing accommodation; provided, however, that 4 nothing in this subdivision shall prohibit a member of the reserve armed 5 forces of the United States or in the organized militia of the state 6 from voluntarily disclosing such membership.

7 (c-1) To print or circulate or cause to be printed or circulated any 8 statement, advertisement or publication, or to use any form of application for the purchase, rental or lease of such housing accommodation or 9 10 make any record or inquiry in connection with the prospective to 11 purchase, rental or lease of such a housing accommodation which 12 expresses, directly or indirectly, any limitation, specification or discrimination as to race, creed, color, national origin, sexual orien-13 14 military status, sex, age, disability, marital status, LAWFUL tation, 15 SOURCE OF INCOME or familial status, or any intent to make any such 16 limitation, specification or discrimination.

17 S 3. Subparagraphs 1, 2 and 3 of paragraph (a) of subdivision 5 of 18 section 296 of the executive law, as amended by chapter 106 of the laws 19 of 2003, are amended to read as follows:

(1) To refuse to sell, rent, lease or otherwise to deny to or withhold from any person or group of persons such a housing accommodation because of the race, creed, color, national origin, sexual orientation, military status, sex, age, disability, marital status, LAWFUL SOURCE OF INCOME or familial status of such person or persons, or to represent that any housing accommodation or land is not available for inspection, sale, rental or lease when in fact it is so available.

(2) To discriminate against any person because of race, creed, color, national origin, sexual orientation, military status, sex, age, disability, marital status, LAWFUL SOURCE OF INCOME or familial status in the terms, conditions or privileges of the sale, rental or lease of any such housing accommodation or in the furnishing of facilities or services in connection therewith.

33 (3) To print or circulate or cause to be printed or circulated any 34 statement, advertisement or publication, or to use any form of application for the purchase, rental or lease of such housing accommodation or 35 36 make any record or inquiry in connection with the prospective to 37 purchase, rental or lease of such a housing accommodation which 38 expresses, directly or indirectly, any limitation, specification or 39 discrimination as to race, creed, color, national origin, sexual orien-40 tation, military status, sex, age, disability, marital status, LAWFUL 41 SOURCE OF INCOME or familial status, or any intent to make any such 42 limitation, specification or discrimination.

43 S 4. Section 296 of the executive law is amended by adding a new 44 subdivision 20 to read as follows:

20. THE PROVISIONS OF THIS SUBDIVISION, AS THEY RELATE TO UNLAWFUL
discriminatory practices on the basis of lawful source of income, shall
not apply to housing accommodations that contain a total of five or
fewer housing units, provided, however:

(A) THE PROVISIONS OF THIS SUBDIVISION SHALL APPLY TO TENANTS SUBJECT
TO RENT CONTROL LAWS WHO RESIDE IN HOUSING ACCOMMODATIONS THAT CONTAIN A
TOTAL OF FIVE OR FEWER UNITS AS OF THE EFFECTIVE DATE OF THIS SUBDIVISION; AND PROVIDED, HOWEVER:

53 (B) THE PROVISIONS OF THIS SUBDIVISION SHALL APPLY TO ALL HOUSING 54 ACCOMMODATIONS, REGARDLESS OF THE NUMBER OF UNITS CONTAINED IN EACH, OF 55 ANY PERSON WHO HAS THE RIGHT TO SELL, RENT OR LEASE OR APPROVE THE SALE, 56 RENTAL OR LEASE OF AT LEAST ONE HOUSING ACCOMMODATION WITHIN NEW YORK 1 STATE THAT CONTAINS SIX OR MORE HOUSING UNITS, CONSTRUCTED OR TO BE 2 CONSTRUCTED, OR AN INTEREST THEREIN.

3 S 5. The executive law is amended by adding a new section 298-b to 4 read as follows:

5 S 298-B. PUNITIVE PENALTIES FOR CERTAIN VIOLATIONS. NOTWITHSTANDING 6 ANY PROVISION OF LAW TO THE CONTRARY, IN ANY FINDING OF A VIOLATION OF 7 SUBDIVISION TWO-A OR SUBDIVISION FIVE OF SECTION TWO HUNDRED NINETY-SIX OF THIS ARTICLE, WHERE SUCH VIOLATION INVOLVES DISCRIMINATION ON THE 8 BASIS OF LAWFUL SOURCE OF INCOME THE COMMISSIONER SHALL IMPOSE A PUNI-9 10 TIVE PENALTY OF NOT LESS THAN TWENTY-FIVE HUNDRED DOLLARS AND NOT MORE THAN FIVE THOUSAND DOLLARS AGAINST THE OWNER, LESSEE, SUB-LESSEE, ASSIG-11 NEE, OR MANAGING AGENT OF SUCH HOUSING ACCOMMODATION FOUND IN VIOLATION. 12 S 6. This act shall take effect immediately and shall apply to all 13 14 causes of action filed on and after such effective date.
