AN ACT to amend the criminal procedure law and the family court act, in relation to notification of service of ex parte orders of protection

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The criminal procedure law is amended by adding a new 2 section 530.13-A to read as follows:

3 S 530.13-A NOTIFICATION OF SERVICE OF EX PARTE ORDER OF PROTECTION.

4 1. A COMPLAINANT WHO IS GRANTED AN EX PARTE ORDER OF PROTECTION BY THE 5 COURT AND A COMPLAINANT WHO REQUESTS THAT AN ΕX PARTE ORDER OF 6 PROTECTION BE GRANTED BY THE COURT, WHO WISHES TO BE NOTIFIED WHEN AN EX PARTE ORDER OF PROTECTION IS SERVED ON THE 7 PERSON AGAINST WHOM THE 8 IS MADE, SHALL NOTIFY THE COURT CLERK OF THE MANNER IN WHICH COMPLAINT 9 HE OR SHE WISHES TO BE NOTIFIED. NOTIFICATION BY MAIL, TELEPHONE, E-MAIL OR OTHER MEANS OF ELECTRONIC COMMUNICATION SHALL BE USED BY THE 10 COURT, REQUESTED, AND IF THE COURT HAS THE EQUIPMENT TO MAKE SUCH COMMUNI-ΙF 11 THE COURT SHALL INFORM ALL COMPLAINANTS WHO ARE GRANTED 12 CATION. AN EX PARTE ORDER OF PROTECTION AND WHO REQUEST AN 13 ΕX PARTE ORDER OF 14 PROTECTION OF THEIR RIGHT TO BE NOTIFIED WHEN THE ORDER OF PROTECTION IS 15 SERVED.

2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO 16 THECONTRARY, ANY 17 POLICE OFFICER, PEACE OFFICER OR OTHER PERSON WHO SERVES AN EX PARTE ORDER OF PROTECTION ON A PERSON AGAINST WHOM A COMPLAINT HAS 18 BEEN MADE 19 SHALL IMMEDIATELY NOTIFY THE CLERK OF THE COURT WHICH MADE SAID ORDER THAT THE SERVICE HAS BEEN MADE. AFTER NOTIFICATION TO THE CLERK OF 20 THETHAT SERVICE OF AN EX PARTE ORDER OF PROTECTION HAS BEEN MADE, OR 21 COURT UPON SERVICE OF SUCH ORDER BY A COURT EMPLOYEE UPON A PERSON 22 AGAINST WHOM A COMPLAINT HAS BEEN MADE, THE CLERK OF THE COURT WHICH ISSUED SUCH 23 24 ORDER SHALL NOTIFY THE COMPLAINANT IMMEDIATELY, IN THE MANNER SPECIFIED 25 BY THE COMPLAINANT, THAT SUCH SERVICE HAS BEEN MADE.

1 S 2. The family court act is amended by adding a new section 153-d to 2 read as follows:

3 S 153-D. NOTIFICATION OF SERVICE OF EX PARTE ORDER OF PROTECTION. 1. 4 A COMPLAINANT WHO IS GRANTED AN EX PARTE ORDER OF PROTECTION BY THE 5 COURT AND A COMPLAINANT WHO REQUESTS THAT AN EX PARTE ORDER OF 6 PROTECTION BE GRANTED BY THE COURT, WHO WISHES TO BE NOTIFIED WHEN AN EX 7 PARTE ORDER OF PROTECTION IS SERVED ON THE PERSON AGAINST WHOM THE COMPLAINT IS MADE, SHALL NOTIFY THE COURT CLERK OF THE MANNER IN WHICH 8 HE OR SHE WISHES TO BE NOTIFIED. NOTIFICATION BY MAIL, TELEPHONE, E-MAIL 9 10 OR OTHER MEANS OF ELECTRONIC COMMUNICATION SHALL BE USED BY THE COURT, REQUESTED, AND IF THE COURT HAS THE EQUIPMENT TO MAKE SUCH COMMUNI-11 ΙF 12 CATION. THE COURT SHALL INFORM ALL COMPLAINANTS WHO ARE GRANTED AN EX PARTE ORDER OF PROTECTION AND WHO REQUEST AN EX PARTE ORDER OF 13 14 PROTECTION OF THEIR RIGHT TO BE NOTIFIED WHEN THE ORDER OF PROTECTION IS SERVED. 15

16 2. NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, ANY 17 POLICE OFFICER, PEACE OFFICER OR OTHER PERSON WHO SERVES AN EX PARTE ORDER OF PROTECTION ON A PERSON AGAINST WHOM A COMPLAINT HAS 18 BEEN MADE 19 SHALL IMMEDIATELY NOTIFY THE CLERK OF THE COURT WHICH MADE SAID ORDER THAT THE SERVICE HAS BEEN MADE. AFTER NOTIFICATION TO THE CLERK OF THE 20 21 COURT THAT SERVICE OF AN EX PARTE ORDER OF PROTECTION HAS BEEN MADE, OR UPON SERVICE OF SUCH ORDER BY A COURT EMPLOYEE UPON A PERSON AGAINST 22 WHOM A COMPLAINT HAS BEEN MADE, THE CLERK OF THE COURT WHICH ISSUED SUCH 23 ORDER SHALL NOTIFY THE COMPLAINANT IMMEDIATELY, IN THE MANNER SPECIFIED 24 BY THE COMPLAINANT, THAT SUCH SERVICE HAS BEEN MADE. 25

26 S 3. This act shall take effect on the sixtieth day after it shall 27 have become a law.
