AN ACT to amend the public authorities law, in relation to public authority accountability and security

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The public authorities law is amended by adding a new 2 section 2933 to read as follows:
 - S 2933. PUBLIC AUTHORITY ACCOUNTABILITY AND SECURITY. ANY PUBLIC AUTHORITY WHICH PROVIDES SURFACE BUS TRANSPORTATION, OR CONTRACTS FOR THE PROVISION OF SURFACE BUS TRANSPORTATION, IN THE COUNTY OF QUEENS SHALL:
 - 1. IN COOPERATION WITH THE POLICE DEPARTMENT OF THE CITY OF NEW YORK, PERFORM A SECURITY AUDIT OF ALL ITS SURFACE BUS TRANSPORTATION ROUTES WITHIN THE COUNTY OF QUEENS, AND SHALL MAKE A REPORT WITH RECOMMENDATIONS AS TO HOW IT MAY PROVIDE FOR THE INCREASED SAFETY AND SECURITY OF ITS RIDERS, TO BOTH THE SENATE AND ASSEMBLY STANDING COMMITTEES ON
- 11 ITS RIDERS, TO BOTH THE SENATE AND ASSEMBLY STANDING COMMITTEES ON 12 CORPORATIONS, AUTHORITIES AND COMMISSIONS, ON OR BEFORE MARCH FIFTEENTH,
- 13 TWO THOUSAND FOURTEEN; AND

- 14 2. DEVELOP AND IMPLEMENT A PLAN TO INCREASE ROUTES AND RIDERSHIP OF SUCH SURFACE BUS TRANSPORTATION PROVIDED WITHIN THE COUNTY OF QUEENS BY 16 JANUARY FIFTEENTH, TWO THOUSAND SIXTEEN.
- 17 S 2. This act shall take effect immediately.
