AN ACT to amend the education law and the public health law, in relation to out-of-state clinical laboratory practitioners

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 8607 of the education law is amended by adding a new subdivision 4 to read as follows:

- 4. PURSUANT TO SUBDIVISION NINE OF SECTION FIVE HUNDRED SEVENTY-SIX OF THE PUBLIC HEALTH LAW, THE COMMISSIONER SHALL CONSULT WITH THE COMMIS-OF HEALTH ON (A) THE ESTABLISHMENT OF STANDARDS OF EDUCATION FOR OUT-OF-STATE CLINICAL LABORATORY PRACTITIONERS, AND (B) DETERMINING WHETHER THE EDUCATIONAL COMPONENTS OF OTHER JURISDICTIONS' PERSONNEL LICENSING PROGRAMS ARE SIGNIFICANTLY COMPARABLE TO THE EDUCATION REOUIREMENTS ESTABLISHED BY THE DEPARTMENT IN PARAGRAPH (B) OF SUBDIVI-SION ONE OF SECTION EIGHTY-SIX HUNDRED FIVE, PARAGRAPH (B) OF SUBDIVI-SION TWO OF SECTION EIGHTY-SIX HUNDRED FIVE, SUBDIVISION TWO OF SECTION EIGHTY-SIX HUNDRED SIX, AND SUBDIVISION TWO OF SECTION EIGHTY-SIX HUNDRED SIX-A OF THIS ARTICLE.
- S 2. Section 576 of the public health law is amended by adding a new subdivision 9 to read as follows:
- 15 9. BY JULY FIRST, TWO THOUSAND TWELVE, 16 THE DEPARTMENT SHALL ADOPT 17 REGULATIONS THAT ESTABLISH OUALIFICATIONS FOR CLINICAL LABORATORY PRAC-TITIONERS PRACTICING IN OUT-OF-STATE LABORATORIES LICENSED UNDER 18 THIS 19 ARTICLE THAT ARE SUBSTANTIALLY EQUIVALENT TO QUALIFICATIONS ESTABLISHED BY THE EDUCATION DEPARTMENT, INCLUDING THE REQUIREMENT FOR AN 20 ISSUED BY A RECOGNIZED ACCREDITING ORGANIZATION THAT IS SIMILAR TO 21 22 THOSE EXAMS ADMINISTERED BY THE EDUCATION DEPARTMENT UNDER ARTICLE 23 SIXTY-FIVE OF THEEDUCATION LAW. IN CONSULTATION WITH THE HUNDRED 24 EDUCATION DEPARTMENT, THE DEPARTMENT SHALL (A) ESTABLISH **STANDARDS** 25 EDUCATION FOR OUT-OF-STATE CLINICAL LABORATORY PRACTITIONERS, AND (B)

DETERMINE WHETHER THE EDUCATIONAL COMPONENTS OF OTHER JURISDICTIONS' PERSONNEL LICENSING PROGRAMS ARE SIGNIFICANTLY COMPARABLE TO THE EDUCATIONAL REQUIREMENTS IN SECTIONS EIGHTY-SIX HUNDRED FIVE, EIGHTY-SIX HUNDRED SIX, AND EIGHTY-SIX HUNDRED SIX-A OF THE EDUCATION LAW.

- S 3. The opening paragraph of subdivision 2 of section 575 of the public health law is designated paragraph (a) and a new paragraph (b) is added to read as follows:
- 8 (B) NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, 9 COMMISSIONER SHALL REQUIRE AN ATTESTATION FROM THE DIRECTOR OF A CLIN-10 ICAL LABORATORY LOCATED OUTSIDE OF NEW YORK STATE AND LICENSED OR SEEK-ING LICENSURE UNDER THIS TITLE, THAT ALL CLINICAL LABORATORY PRACTITION-11 12 ERS, AS DEFINED IN SECTION EIGHTY-SIX HUNDRED ONE OF THE EDUCATION LAW, PRACTICING CLINICAL LABORATORY TECHNOLOGY ON OR INVOLVING NEW YORK STATE 13 14 SPECIMENS, UNLESS EXEMPT FROM LICENSURE OR CERTIFICATION PURSUANT 15 SECTION EIGHTY-SIX HUNDRED NINE OF THE EDUCATION LAW, WHO DO NOT HOLD 16 THE APPROPRIATE VALID LICENSE, PERMIT OR CERTIFICATE ISSUED PURSUANT TO 17 ARTICLE ONE HUNDRED SIXTY-FIVE OF THE EDUCATION LAW, MEET THE STANDARDS AND REQUIREMENTS ESTABLISHED IN SUBDIVISION NINE OF SECTION FIVE HUNDRED 18 19 SEVENTY-SIX OF THIS TITLE. RECORDS OF ON-SITE REVIEWS OF CREDENTIALS WILL BE MAINTAINED BY BOTH THE LABORATORY AND THE DEPARTMENT. 20
- 21 S 4. This act shall take effect on the one hundred eightieth day after 22 it shall have become a law.
