AN ACT to amend the penal law, in relation to possession of a rifle or  
shotgun at a shooting range by a person between the ages of ten and  
twelve

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-  
BLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision a of section 265.20 of the penal law is amended  
2     by adding a new paragraph 7-f to read as follows:  
3     7-F. POSSESSION, AT AN INDOOR OR OUTDOOR SHOOTING RANGE FOR THE  
4     PURPOSE OF LOADING AND FIRING, OF A RIFLE OR SHOTGUN, THE PROPELLING  
5     FORCE OF WHICH IS GUNPOWDER BY A PERSON UNDER TWELVE YEARS OF AGE BUT  
6     NOT UNDER TEN, UNDER THE IMMEDIATE SUPERVISION, GUIDANCE AND INSTRUCTION  
7     OF (A) A DULY COMMISSIONED OFFICER OF THE UNITED STATES ARMY, NAVY, AIR  
8     FORCE, MARINE CORPS OR COAST GUARD, OR OF THE NATIONAL GUARD OF THE  
9     STATE OF NEW YORK; OR (B) A DULY QUALIFIED ADULT CITIZEN OF THE UNITED  
10    STATES WHO HAS BEEN GRANTED A CERTIFICATE AS AN INSTRUCTOR IN SMALL ARMS  
11    PRACTICE ISSUED BY THE UNITED STATES ARMY, NAVY, AIR FORCE OR MARINE  
12    CORPS, OR BY THE ADJUTANT GENERAL OF THIS STATE, OR BY THE NATIONAL  
13    RIFLE ASSOCIATION OF AMERICA, A NOT-FOR-PROFIT CORPORATION DULY ORGAN-  
14    IZED UNDER THE LAWS OF THIS STATE; OR (C) A PARENT, GUARDIAN, OR A  
15    PERSON OVER THE AGE OF EIGHTEEN DESIGNATED IN WRITING BY SUCH PARENT OR  
16    GUARDIAN WHO SHALL HAVE A CERTIFICATE OF QUALIFICATION IN RESPONSIBLE  
17    HUNTING, INCLUDING SAFETY, ETHICS, AND LANDOWNER RELATIONS-HUNTER  
18    RELATIONS, ISSUED OR HONORED BY THE DEPARTMENT OF ENVIRONMENTAL CONSER-  
19    VATION; OR (D) AN AGENT OF THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION  
20    APPOINTED TO CONDUCT COURSES IN RESPONSIBLE HUNTING PRACTICES PURSUANT  
21    TO ARTICLE ELEVEN OF THE ENVIRONMENTAL CONSERVATION LAW, PROVIDED THAT  
22    THE PERSON PROVIDING GUIDANCE MAY PROVIDE SUPERVISION TO ONLY ONE PERSON  
23    BETWEEN THE AGE OF TEN AND SIXTEEN AT ANY ONE TIME, AND THE FIREARM
