- AN ACT to amend the public health law, in relation to directing the commissioner of health to ensure that space is provided on any consent application so that the applicant shall register or decline registration in the New York state donate life registry for organ and tissue donations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act shall be known and may be cited as "Lauren's law". 2 S 2. Subdivision 2 of section 4310 of the public health law, as 3 amended by chapter 161 of the laws of 2010, is amended to read as 4 follows:

5 2. Such registration of consent to make an anatomical gift can be made 6 through (a) indication made on the application or renewal form of a 7 license, (b) indication made on a non-driver identification card appli-8 cation or renewal form, (c) enrolling in the registry website maintained by the department, which may include using an electronic signature under 9 10 regulations of the commissioner and subject to article three of the state technology law, (d) indication made on a voter registration form 11 pursuant to subdivision five of section 5-210 of the election 12 law, or through any other method identified by the commissioner. 13 (e) THE 14 COMMISSIONER SHALL FURTHER ENSURE THAT SPACE IS PROVIDED ON ANY CONSENT 15 APPLICATION SO THAT THE APPLICANT SHALL REGISTER OR DECLINE REGISTRATION THE NEW YORK STATE DONATE LIFE REGISTRY FOR ORGAN AND TISSUE 16 IN DONATIONS UNDER THIS SECTION AND THAT THE FOLLOWING IS 17 STATED ON THE

THE 3 DEPARTMENT SHALL NOT MAINTAIN ANY RECORDS OF ANY PERSON WHO CHECKS "'NO' THIS TIME". The registration shall take effect upon the department 4 AΤ sending written notice of the registration to the person enrolling in 5 6 the registry. In making regulations on using an electronic signature for 7 registration of consent, the commissioner shall consult with the а 8 director of the office of technology.

9 S 3. This act shall take effect on the one hundred twentieth day after 10 it shall have become a law; provided, however, that effective immediate-11 ly, the addition, amendment and/or repeal of any rule or regulation 12 necessary for the implementation of this act on its effective date are 13 authorized and directed to be made and completed on or before such 14 effective date.
