- AN ACT to amend the public authorities law, in relation to prohibiting bonuses for employees of public authorities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The public authorities law is amended by adding a new 2 section 2854 to read as follows:

3 S 2854. PROHIBITION ON PAYMENT OF BONUSES. 1. NOTWITHSTANDING ANY 4 PROVISION OF LAW, IN NO EVENT SHALL AN INDIVIDUAL BY OR ON BEHALF OF 5 STATE AUTHORITIES RECEIVE ADDITIONAL COMPENSATION AS A REWARD FOR 6 SERVICES ALREADY RENDERED AND FULLY COMPENSATED, SUCH AS A BONUS OR 7 THAT RETROACTIVE PAY INCREASE; PROVIDED, HOWEVER, NOTHING INTHIS 8 DEEMED TO PREVENT A STATE AUTHORITY FROM PAYING AN SECTION SHALL BE 9 INCENTIVE TO AN INDIVIDUAL BY OR ON BEHALF OF А STATE AUTHORITY IN WITH A WRITTEN INCENTIVE PROGRAM ADOPTED BY THE BOARD OF THE 10 ACCORDANCE STATE AUTHORITY. NO INCENTIVE SHALL BE PAID UNLESS A 11 WRITTEN AGREEMENT SETTING FORTH A SPECIFIC PERFORMANCE GOAL OR GOALS THAT MUST BE ACHIEVED 12 13 THE INCENTIVE OR INCENTIVES IS EXECUTED BY THE EMPLOYEE BEFORE TΟ EARN 14 PERFORMANCE TO ACHIEVE THE GOAL OR GOALS IS BEGUN; AND THE INCENTIVE PAID UNLESS WRITTEN DOCUMENTATION OF THE ACHIEVEMENT OF 15 SHALL NOT BE SUCH PERFORMANCE GOAL OR GOALS HAS BEEN PLACED IN THE EMPLOYEE'S PERSON-16 17 NEL FILE.

1 2. IN NO EVENT SHALL MEMBERS OF THE BOARD OF A STATE AUTHORITY RECEIVE 2 BONUS OR INCENTIVE PAYMENTS. NOTHING IN THIS SECTION SHALL BE DEEMED TO 3 PREVENT RETROACTIVE COMPENSATION INCREASES UNDER A COLLECTIVE BARGAINING 4 AGREEMENT.

5 S 2. This act shall take effect immediately.
