AN ACT to amend the education law, in relation to requiring newly certified teachers to be competent in the use of an epinephrine auto-injector

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 3004 of the education law is amended by adding a new subdivision 2-a to read as follows:

2-A. THE COMMISSIONER SHALL PRESCRIBE REGULATIONS REOUIRING

PERSONS APPLYING ON OR AFTER JANUARY FIRST, TWO THOUSAND THIRTEEN FOR A TEACHING CERTIFICATE OR LICENSE, INCLUDING BUT NOT LIMITED TO A CERTIF-6 OR LICENSE VALID FOR SERVICE AS A CLASSROOM TEACHER, TEACHING 7 ASSISTANT, PUPIL PERSONNEL SERVICE PROFESSIONAL, SCHOOL ADMINISTRATOR OR 8 SUPERVISOR OR SUPERINTENDENT OF SCHOOLS, SHALL, IN ADDITION TO OTHER CERTIFICATION OR LICENSING REQUIREMENTS, HAVE COMPLETED A COURSE 9 OR TRAINING IN THE USE OF AN EPINEPHRINE AUTO-INJECTOR AND SHALL PROVIDE 10 DEPARTMENT WITH DOCUMENTATION SHOWING THAT THE APPLICANT 11 12 SUCCESSFULLY COMPLETED SUCH TRAINING. THE COMMISSIONER SHALL PRESCRIBE REGULATIONS REQUIRING THAT TEACHER PREPARATION INSTITUTIONS, IN THE

- 13 REGULATIONS REQUIRING THAT TEACHER PREPARATION INSTITUTIONS, IN THE TWO 14 THOUSAND TWELVE--TWO THOUSAND THIRTEEN ACADEMIC YEAR, INCLUDE INSTRUC-
- 15 TION IN THE ADMINISTRATION OF AN EPINEPHRINE AUTO-INJECTOR. SUCH TRAIN-
- 16 ING SHALL BE LIMITED TO THE USE OF AN EPINEPHRINE AUTO-INJECTOR IN EMER-
- 17 GENCY SITUATIONS WHERE A REGISTERED NURSE OR OTHER LICENSED HEALTH CARE
- 18 WORKER IS NOT AVAILABLE.
- 19 S 2. This act shall take effect immediately.
