AN ACT to amend the administrative code of the city of New York, in relation to requiring inspection stickers to be visible to the public

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision f of section 19-504 of the administrative code 2 of the city of New York, as amended by local law number 31 of the city 3 of New York for the year 2010, is amended to read as follows:

f. All taxicabs now or hereafter licensed pursuant to the provisions 4 5 of this chapter shall be inspected at an inspection facility operated by б least once every four months, in accordance with a the commission at 7 procedure to be established by the commission WHEREIN SUCH PROCEDURE 8 TAXICAB IN A LOCATION VISIBLE TO THE SHALL INCLUDE AFFIXING TO THE GENERAL PUBLIC, A STICKER INDICATING THE DATE FOR THE NEXT SUBSEQUENT 9 INSPECTION REQUIRED BY THIS SUBDIVISION. All other vehicles now or 10 hereafter licensed pursuant to the provisions of this chapter other than 11 12 commuter vans shall be inspected at official inspection stations licensed by the commissioner of motor vehicles pursuant to section three 13 hundred three of the vehicle and traffic law at least once every four 14 15 months in accordance with the regulations of the commissioner of motor 16 vehicles, codified in part seventy-nine of title fifteen of the official 17 compilation of codes, rules and regulations of the state of New York (15 N.Y.C.R.R. part 79). All commuter vans now or hereafter licensed pursu-18 ant to the provisions of this chapter shall be inspected and shall meet 19 safety standards as provided in paragraph two of subdivision a of 20 21 section 19-504.3 of this chapter. If any taxicab fails to pass its 22 inspection for any reason relating to the requirements established by 23 the New York state department of motor vehicles, it shall be reinspected. The fee payable to the commission for each inspection and each 24

reinspection required for the issuance of a certificate of inspection 1 a taxicab, inclusive of the issuance of such certificate, shall not 2 for exceed fifty dollars. The fees payable to the official inspection 3 4 station for the inspection and the issuance of a certificate of inspection for all other licensed vehicles other than commuter vans shall be the fees charged and collected pursuant to section three 5 6 7 hundred five of the vehicle and traffic law. The commission or any other 8 agency authorized by law may conduct on-street inspections of vehicles licensed pursuant to the provisions of this chapter. The date of the inspection of a taxicab, THE DATE OF THE NEXT SUBSEQUENT INSPECTION AS 9 10 REQUIRED BY THIS SUBDIVISION, and the signature of the persons making 11 the inspection shall be recorded upon the rate card in the space 12 provided therefor. An owner shall be ordered by the commission to repair 13 14 or replace his or her licensed vehicle where it appears that it no long-15 er meets the reasonable standards for safe operation prescribed by the commission. Upon failure of such owner to have his or her vehicle 16 17 inspected or to comply with any such order within ten days after service 18 thereof, the license shall be suspended; upon failure of such owner to 19 comply with any such order within one hundred twenty days after service 20 thereof, the license may, at the discretion of the commission, be deemed 21 to have been abandoned by nonuser. 22 2.
