AN ACT to amend the environmental conservation law, in relation to authorizing the hunting of big game in the county of Albany with pistols, rifles, shotguns, crossbows and long bows; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Items (d) and (e) of paragraph a of subdivision 2 of
2 section 11-0907 of the environmental conservation law, as amended by
3 section 11 of chapter 483 of the laws of 2010, are amended to read as
4 follows:
5 (d) Eastern region, Deer, first Monday Pistol, shotgun,
6 except ALBANY, after November 15 crossbow,
7 Columbia, Fulton, through first Tuesday muzzle loading firearm
8 Orange, Rensselaer, after December 7 or long bow only
9 Saratoga, Washington
10 Counties and those
11 counties or portions
12 thereof listed in
13 item (i) of this
14 paragraph

29 S 3. This act shall take effect immediately, provided that:
30 a. the amendments to items (d) and (e) of paragraph a of subdivision 2

33 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as
34 amended, when upon such date the provisions of section two of this act
35 shall take effect;
36 b. the amendments to items (d) and (e) of paragraph a of subdivision 2
37 of section 11-0907 of the environmental conservation law made by section
38 two of this act shall be subject to the expiration and reversion of such
39 paragraph pursuant to section 17 of chapter 483 of the laws of 2010, as

41 c. nothing contained in this act shall be construed so as to extend
42 the provisions of this act beyond January 1, 2014, when upon such date
43 this act shall expire and the provisions contained herein shall be
