- AN ACT to amend the public health law, in relation to designating certain additional substances as schedule I hallucinogenic or stimulant controlled substances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1.
