AN ACT authorizing the transfer of certain state lands in the town of Orangetown

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Notwithstanding any other law to the contrary, the commissioner of general services is authorized to sell unappropriated state land, including any buildings and improvements thereon erected within the bounds set forth in section two of this act, to the town of Orangetown for fair market value, and upon such additional terms and conditions as the commissioner may deem proper. The town shall have ninety days in which to advise the commissioner of general services whether or not it wishes to acquire such unappropriated state land for a public purpose. If it wishes to acquire such unappropriated state land, the town shall have one hundred twenty days from so notifying the commissioner in which to conclude the negotiation of the sale.

S 2. The lands, with buildings and improvements thereon erected, subject to the provisions of this act are located within that part of the town of Orangetown in the county of Rockland bounded by a line described as follows:

BEGINNING at the intersection of the northern line of county of Rock-land route number twenty and the western line of the Palisades Intestate Parkway; thence westerly along the northern line of county of Rockland route number twenty to the intersection of the northern line of county of Rockland route number twenty and the eastern line of county of Rockland route number twenty-three; thence northerly along the eastern line of county of Rockland route number twenty-three to the intersection of the eastern line of county of Rockland route number twenty-three and the southern line of Convent Road; thence easterly along the southern line of Convent Road to the intersection of the southern line of Convent Road

and the western line of the Palisades Interstate Parkway; thence southerly along the western line of the Palisades Interstate Parkway to the point of BEGINNING.

- S 3. No existing remedy or executed contract, lease or agreement shall be impaired by this act.
- S 4. Any transaction for the sale, conveyance or transfer of land authorized by this act is subject to any statement of facts an accurate survey may show pertaining to any such land and is further subject to any covenants, conditions, restrictions, easements and rights-of-way, if any, contained in instruments of record affecting said premises so far as the same may now be in force and effect.
- S 5. This act shall take effect immediately.
