AN ACT to amend the social services law, in relation to expanding the persons responsible for reporting cases of suspected child abuse

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph (a) of subdivision 1 of section 413 of the social 2 services law, as amended by chapter 91 of the laws of 2011, is amended 3 to read as follows:

4 following persons and officials are required to report or (a) The 5 cause a report to be made in accordance with this title when they have 6 reasonable cause to suspect that a child coming before them in their 7 professional or official capacity is an abused or maltreated child, or 8 when they have reasonable cause to suspect that a child is an abused or maltreated child where the parent, guardian, custodian or other person 9 responsible for such child comes before them in their profes-10 legally 11 sional or official capacity and states from personal knowledge facts, conditions or circumstances which, if correct, would render the child an 12 abused or maltreated child: any physician; registered physician assist-13 dental 14 ant; surgeon; medical examiner; coroner; dentist; hygienist; 15 osteopath; optometrist; chiropractor; podiatrist; resident; intern; 16 psychologist; registered nurse; social worker; emergency medical techni-17 cian; licensed creative arts therapist; licensed marriage and family 18 therapist; licensed mental health counselor; licensed psychoanalyst; 19 hospital personnel engaged in the admission, examination, care or treat-20 ment of persons; a Christian Science practitioner; school official, is not limited to school teacher, school guidance 21 which includes but 22 counselor, school psychologist, school social worker, school nurse, school administrator or other school personnel required to hold a teach-23 ing or administrative license or certificate; SCHOOL ATHLETIC DIRECTOR, 24 25 SCHOOL COACH, SCHOOL ASSISTANT COACH; social services worker; director 26 of a children's overnight camp, summer day camp or traveling summer day 27 camp, as such camps are defined in section thirteen hundred ninety-two 28 of the public health law; day care center worker; school-age child care
