AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for deer hunting in the county of Chautauqua; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907 of the environmental conservation law, as amended by section 11 of chapter 483 of the laws of 2010, is amended to read as follows:

(i) The counties of Deer, the first Monday Pistol, shotgun, Allegany, Cattaraugus, after November 15 crossbow,
