AN ACT to amend the environmental conservation law, in relation to allowing the use of rifles for deer hunting in the county of Chautauqua; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (i) of paragraph a of subdivision 2 of section 11-0907
2 of the environmental conservation law, as amended by section 11 of chap-
3 ter 483 of the laws of 2010, is amended to read as follows:
4 (i) The counties of Deer, the first Monday Pistol, shotgun,
5 Allegany, Cattaraugus, after November 15 crossbow,
6 CHAUTAUQUA EXCEPT through first Tuesday muzzle loading
7 THAT PORTION OF after December 7 firearm, rifle or

23 S 3. This act shall take effect immediately, provided that:

24 a. the amendments to item (i) of paragraph a of subdivision 2 of
25 section 11-0907 of the environmental conservation law made by section
26 one of this act shall be subject to the expiration and reversion of such
27 paragraph pursuant to section 13 of chapter 600 of the laws of 1993, as
28 amended, when upon such date the provisions of section two of this act
29 shall take effect;

30 b. the amendments to item (i) of paragraph a of subdivision 2 of
31 section 11-0907 of the environmental conservation law made by section
32 two of this act shall be subject to the expiration and reversion of such
33 paragraph pursuant to section 17 of chapter 483 of the laws of 2010, as
34 amended;

35 c. nothing contained in this act shall be construed so as to extend
36 the provisions of this act beyond January 1, 2014, when upon such date
37 this act shall expire and the provisions contained herein shall be
38 deemed repealed.
