- AN ACT to amend the economic development law, in relation to establishing the economic development program evaluation act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The economic development law is amended by adding a new 2 article 15 to read as follows:

8 S 270. DEFINITION. FOR PURPOSES OF THIS ARTICLE, "ECONOMIC DEVELOPMENT PROGRAM" SHALL MEAN A PROGRAM THAT PROVIDES SERVICES FOR THE PURPOSE 9 OF OF THE STATE, PROVIDES TRAINING OR 10 EFFECTING THE ECONOMIC CONDITIONS SERVICES, 11 EMPLOYMENT SUPPORTS AN ECONOMIC DEVELOPMENT ACTIVITY BY 12 ENHANCING THE SKILLS OF THE STATE'S WORKFORCE, PREPARES INDIVIDUALS FOR EMPLOYMENT, IMPROVES OPPORTUNITIES FOR INDIVIDUALS TO BECOME 13 EMPLOYED, 14 OR PROMOTES THE STATE ECONOMY.

S 271. PROGRAM IMPLEMENTATION. 1. ON OR BEFORE SEPTEMBER FIRST, IN THE 15 THIS SECTION BECAME LAW, EACH STATE AGENCY ADMINISTRATIVELY 16 YEAR AFTER RESPONSIBLE FOR ECONOMIC DEVELOPMENT ACTIVITIES SHALL PREPARE A SEPARATE 17 18 PLAN FOR EACH PROGRAM THAT SUCH AGENCY ADMINISTERS. EACH PLAN SHALL 19 INCLUDE A DESCRIPTION OF PROPOSED PROGRAM ACTIVITIES, A DESCRIPTION OF A 20 MECHANISM FOR FUNDING DISTRIBUTION, PROGRAM OBJECTIVES, POPULATION TO BE SERVED, INSTITUTIONS ELIGIBLE TO RECEIVE FUNDS, AND A DESCRIPTION OF THE 21 COORDINATION AND LINKAGES BETWEEN THIS PROGRAM AND OTHER PROGRAM ACTIV-22 23 ITIES FUNDED SEPARATELY. SUCH PLAN SHALL ALSO INCLUDE AN EVALUATION

1 COMPONENT AS PART OF THE IMPLEMENTATION OF EACH PROGRAM WHICH SHALL 2 DESCRIBE HOW THE AGENCY WILL MONITOR THE DELIVERY OF SERVICES UNDER THE 3 PROGRAM AND WHICH SHALL SET FORTH THE MEASURE OF EFFECTIVENESS OF THE 4 SERVICES BEING PROVIDED.

5 2. PROGRAM PLANS SHALL BE SUBMITTED TO THE DEPARTMENT, THE SPEAKER OF 6 THE ASSEMBLY AND THE TEMPORARY PRESIDENT OF THE SENATE, FOR REVIEW AND 7 COMMENT.

8 3. THE PROVISIONS OF THIS SECTION SHALL NOT EXEMPT ANY AGENCY FROM 9 REQUIREMENTS RELATING TO THE PREPARATION AND SUBMISSION OF PROGRAM PLANS 10 PURSUANT TO ANY OTHER PROVISION OF LAW.

11 S 272. EVALUATION. 1. THE EVALUATION COMPONENT OF EACH PROGRAM PLAN 12 SHALL, AT A MINIMUM, INCLUDE THE FOLLOWING:

(A) A STATEMENT ON LEGISLATIVE HISTORY AND INTENT;

14 (B) A STATEMENT OF PROGRAM OBJECTIVES WHICH IDENTIFIES OUTCOMES 15 ATTRIBUTABLE TO THE PROGRAM, ANTICIPATED PERFORMANCE LEVELS, AND INDICA-16 TORS OF THE EFFECTIVENESS OF THE PROGRAM;

(C) DEFINED QUANTITATIVE MEASURES WHICH WILL BE INCLUDED AS 17 PART OF EVALUATION REPORT INCLUDING, BUT NOT LIMITED TO, A DESCRIPTION OF 18 THE 19 THE TARGETED POPULATION, CRITERIA FOR PARTICIPANT SELECTION, DEMOGRAPH-20 ICS ON PARTICIPANTS, MEASURES OF PROGRAM ACTIVITY, INVENTORY OF SERVICES 21 PROVIDED, AND BUDGET INFORMATION ON PROGRAMS AND ADMINISTRATIVE EXPENDI-TURES INCLUDING, BUT NOT LIMITED TO, COSTS PER PARTICIPANT. FOR THOSE 22 PROGRAMS WHERE AN OBJECTIVE IS JOB PLACEMENT, DATA SHALL INCLUDE INFOR-23 MATION ON THE OCCUPATIONS WHICH PARTICIPANTS ENTER, THE RATE OF JOB 24 25 RETENTION, PRE-PROGRAM WAGE EARNINGS AND POST-PROGRAM WAGE EARNINGS AS 26 WELL AS OTHER APPROPRIATE MEASURES WHICH INDICATE THE EXTENT TO WHICH 27 PROGRAM ACTIVITIES MEET PROGRAM OBJECTIVES. OTHER PERFORMANCE INDICATORS 28 THAT APPROPRIATELY DESCRIBE THE EFFECT OF THE PROGRAM AND DATA WHICH 29 REFLECTS FOLLOW-UP ACTIVITY APPROPRIATE TO THE SERVICES PROVIDED SHALL 30 ALSO BE INCLUDED AS PART OF THE EVALUATION REPORT;

31 (D) A STATEMENT OF METHODOLOGY WHICH WILL RESULT IN A COMPARISON OF 32 PROGRAM OUTCOMES AGAINST PROGRAM OBJECTIVES; AND

33 (E) ANY ADDITIONAL EVALUATION INFORMATION AS MAY BE REQUIRED BY LAW.

34 2. (A) THE EVALUATION REPORT FOR EACH PROGRAM SHALL BE SUBMITTED TO 35 THE COMMISSIONER FOR REVIEW AND RECOMMENDATION.

(B) THE REPORT SHALL INCLUDE, AT A MINIMUM, ALL PROGRAM DATA AND AN
ANALYSIS WHICH COMPARES PERFORMANCE OUTCOMES AGAINST PROGRAM OBJECTIVES
AS SPECIFIED IN THE EVALUATION COMPONENT OF THE PROGRAM PLAN DEFINED
HEREIN AND SHALL INCLUDE AN EVALUATION OF ACTIVITY FOR THE COMPLETED
PROGRAM YEAR IMMEDIATELY PRECEDING THE ISSUANCE OF THE REPORT AND AN
INTERIM EVALUATION OF CURRENT PROGRAM YEAR ACTIVITY IF APPLICABLE.

3. BASED ON THE REVIEW CONDUCTED PURSUANT TO PARAGRAPH (A) OF SUBDIVI-42 43 SION TWO OF THIS SECTION, THE DEPARTMENT SHALL PREPARE A UNIFIED SUMMARY EVALUATION REPORTS SUBMITTED BY EACH AGENCY PURSUANT TO THIS ARTICLE 44 OF 45 FOR SUBMISSION TO THE SPEAKER OF THE ASSEMBLY AND THE TEMPORARY PRESI-DENT OF THE SENATE NO LATER THAN JANUARY THIRTY-FIRST, TWO THOUSAND 46 47 THIRTEEN AND EACH YEAR THEREAFTER PROVIDED, HOWEVER, THAT THE DEPARTMENT SHALL MAKE AVAILABLE EACH INDIVIDUAL PROGRAM EVALUATION REPORT SUBMITTED 48 49 PURSUANT TO THIS ARTICLE UPON REQUEST OF THE LEGISLATURE. THE DEPARTMENT 50 SHALL INCLUDE IN SUCH SUMMARY RECOMMENDATIONS TO THE GOVERNOR AND THE LEGISLATURE RELATING TO IMPROVED PROGRAM COORDINATION AND SERVICE DELIV-51 52 ERY, PROGRAM IMPROVEMENTS OR ENHANCEMENTS AND NECESSARY STATUTORY CHANG-53 ES.

54 4. THE PROVISIONS OF THIS SECTION SHALL NOT EXEMPT ANY AGENCY FROM 55 REQUIREMENTS PURSUANT TO ANY OTHER PROVISION OF LAW.

56 S 2. This act shall take effect immediately.
