- Introduced by Sens. DeFRANCISCO, GRIFFO, LARKIN, LAVALLE, MAZIARZ, SALAND -- read twice and ordered printed, and when printed to be committed to the Committee on Transportation
- AN ACT to amend the navigation law, the parks, recreation and historic preservation law and the vehicle and traffic law, in relation to the effect of prior conviction for operation of certain vehicles while intoxicated upon imposition of penalties for boating while intoxicated

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as 2 "Tiffany Heitkamp's law".

3 S 2. Section 49-a of the navigation law is amended by adding a new 4 subdivision 14 to read as follows:

5 14. EFFECT OF PRIOR CONVICTION FOR OPERATION OF A MOTOR VEHICLE, SNOW-6 MOBILE, OR ALL TERRAIN VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOL OR 7 DRUGS. 25 S 4. Section 1192 of the vehicle and traffic law is amended by adding 26 a new subdivision 8-b to read as follows:

8-B. EFFECT OF PRIOR CONVICTION FOR OPERATION OF A VESSEL, SNOWMOBILE, 27 OR ALL TERRAIN VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOL OR DRUGS. 43 S 5. This act shall take effect on the one hundred twentieth day after 44 it shall have become a law and shall apply to convictions occurring on 45 and after such date.
