- AN ACT to amend chapter 112 of the laws of 2007 authorizing the commissioner of environmental conservation to discontinue the use of certain land as reserved lands within the Long Island Pine Barrens maritime reserve, in relation to the description of lands to be conveyed by the Longwood central school district to the state of New York

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 4 of chapter 112 of the laws of 2007, relating to 2 authorizing the commissioner of environmental conservation to discontin-3 ue the use of certain land as reserved lands within the Long Island Pine 4 Barrens maritime reserve, is amended to read as follows:

5 S 4. The lands authorized by this act to be conveyed to the people of 6 the state of New York by the Longwood central school district are as 7 follows:

7 S 2. This act shall take effect on the same date and in the same 8 manner as chapter 112 of the laws of 2007, takes effect.
