AN ACT to amend the state finance law, in relation to the cost effectiveness of consultant contracts by the state agencies

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 163 of the state finance law is amended by adding a 2 new subdivision 15 to read as follows:

3 15. CONSULTANT SERVICES. A. BEFORE A STATE AGENCY ENTERS INTO A 4 CONTRACT FOR CONSULTANT SERVICES WHICH IS ANTICIPATED TO COST MORE THAN 5 FIVE HUNDRED THOUSAND DOLLARS IN A TWELVE MONTH PERIOD THE STATE AGENCY 6 SHALL CONDUCT A COST COMPARISON REVIEW TO DETERMINE WHETHER THE SERVICES 7 TO BE PROVIDED BY THE CONSULTANT CAN BE PERFORMED AT EQUAL OR LOWER COST 8 UTILIZING STATE EMPLOYEES, UNLESS THE CONTRACT MEETS ONE OF THE ΒY 9 EXCEPTIONS SET FORTH IN PARAGRAPH B OF THIS SUBDIVISION. AS USED INTHIS SECTION, THE TERM "CONSULTANT SERVICES" SHALL MEAN ANY CONTRACT ENTERED INTO BY A STATE AGENCY FOR ANALYSIS, EVALUATION, RESEARCH, TRAINING, DATA PROCESSING, COMPUTER PROGRAMMING, ENGINEERING, ARCHITEC-10 11 12 TURE, ENVIRONMENTAL, HEALTH SERVICES, MENTAL HEALTH SERVICES, 13 ACCOUNT-14 ING, AUDITING, OR SIMILAR SERVICES, BUT SHALL NOT INCLUDE LEGAL SERVICES OR SERVICES IN CONNECTION WITH LITIGATION INCLUDING EXPERT WITNESSES AND 15 SHALL NOT INCLUDE CONTRACTS FOR CONSTRUCTION OF PUBLIC WORKS. THE COST 16 17 COMPARISON SHALL COMPARE THE ANTICIPATED COST OF CONSULTANT SERVICES WITH THE ANTICIPATED COST OF PROVIDING SIMILAR SERVICES BY STATE EMPLOY-18 19 EES INCLUDING THE COST OF SALARIES AND BENEFITS OF ANY ADDITIONAL STATE 20 EMPLOYEES THAT WOULD BE REOUIRED TO PERFORM THE SERVICES. THEANTIC-COST OF CONSULTANT SERVICES SHALL INCLUDE ALL COSTS ASSOCIATED 21 IPATED WITH THE CONTRACT INCLUDING THE COST TO THE STATE AGENCY OF ADMINISTER-22 23 ING THE CONTRACT.

THE SERVICES ARE INCIDENTAL TO THE PURCHASE OF REAL OR PERSONAL 1 (I) 2 PROPERTY; OR 3 (II) THE CONTRACT IS NECESSARY IN ORDER TO AVOID A CONFLICT OF INTER-4 EST ON THE PART OF THE AGENCY OR ITS EMPLOYEES; OR 5 (III) THE SERVICES ARE OF SUCH A HIGHLY SPECIALIZED NATURE THAT IT IS NOT FEASIBLE TO UTILIZE STATE EMPLOYEES TO PERFORM THEM OR REQUIRE 6 7 SPECIAL EQUIPMENT THAT IS NOT FEASIBLE FOR THE STATE TO PURCHASE OR 8 LEASE; OR 9 (IV) THE SERVICES ARE OF SUCH AN URGENT NATURE THAT IT IS NOT FEASIBLE 10 TO UTILIZE STATE EMPLOYEES; OR (V) THE SERVICES ARE ANTICIPATED TO BE SHORT TERM AND ARE NOT LIKELY 11 12 TO BE EXTENDED OR REPEATED AFTER THE CONTRACT IS COMPLETED. C. NOTHING IN THIS SECTION SHALL BE DEEMED TO AUTHORIZE A STATE AGENCY 13 14 TO ENTER INTO A CONTRACT WHICH IS OTHERWISE PROHIBITED BY LAW. 15 D. ALL DOCUMENTS RELATED TO THE COST COMPARISON REQUIRED BY THIS SUBDIVISION SHALL BE PUBLIC RECORDS SUBJECT TO DISCLOSURE PURSUANT TO 16 17 ARTICLE SIX OF THE PUBLIC OFFICERS LAW. S 2. This act shall take effect on the ninetieth day after it shall 18 19 have become a law; provided, however, that the amendments to section 163 of the state finance law made by section one of this act shall not 20 21 affect the repeal of such section and shall be deemed to repeal there-22 with.
