AN ACT to amend the education law and the public health law, in relation to course work or training in early recognition of and intervention for eating disorders

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 6505-d 2 to read as follows:

S 6505-D. COURSE WORK OR TRAINING IN EARLY RECOGNITION OF AND VENTION FOR EATING DISORDERS. EVERY PHYSICIAN AND PHYSICIAN ASSISTANT PRACTICING IN THE STATE SHALL, ON OR BEFORE JULY FIRST, TWO COMPLETE COURSE WORK OR TRAINING APPROVED BY THE DEPARTMENT REGARDING THE EARLY RECOGNITION OF AND INTERVENTION FOR EATING DISOR-THE DEPARTMENT OF HEALTH, WHICH SHALL BE IN CONSULTATION \mathtt{WITH} CONSISTENT, AS FAR AS APPROPRIATE, WITH ANY STANDARDS OR BEST PRACTICES ESTABLISHED BY THE COMPREHENSIVE CARE CENTERS FOR EATING DISORDERS ESTABLISHED PURSUANT TO ARTICLE TWENTY-SEVEN-J OF THE PUBLIC HEALTH LAW. EACH SUCH PROFESSIONAL SHALL ATTEST TO THE DEPARTMENT AT THE REGISTRATION COMMENCING WITH THE FIRST REGISTRATION AFTER JULY FIRST,

- REGISTRATION COMMENCING WITH THE FIRST REGISTRATION AFTER JULY FIRST, TWO THOUSAND THIRTEEN THAT THE PROFESSIONAL HAS COMPLETED COURSE WORK OR TRAINING IN ACCORDANCE WITH THIS SECTION, PROVIDED, HOWEVER THAT A

BEHAVIORAL INDICATORS OF EATING DISORDERS. THE DEPARTMENT SHALL PROVIDE AN EXEMPTION FROM THIS REQUIREMENT TO ANYONE WHO REQUESTS SUCH AN 3 EXEMPTION AND WHO CLEARLY DEMONSTRATES TO THE DEPARTMENT'S SATISFACTION (I) THERE WOULD BE NO NEED FOR HIM OR HER TO COMPLETE SUCH COURSE 5 WORK OR TRAINING BECAUSE OF THE NATURE OF HIS OR HER PRACTICE, (II) THAT HE OR SHE HAS COMPLETED COURSE WORK OR TRAINING DEEMED BY THE DEPARTMENT 6 7 TO BE EQUIVALENT TO THE COURSE WORK OR TRAINING APPROVED BY THE DEPART-8 MENT PURSUANT TO THIS SECTION OR (III) SOME OTHER GOOD CAUSE PREVENTS THEM FROM COMPLETING SUCH COURSE WORK OR TRAINING. 9

- S 2. Subdivision 1 of section 2805-k of the public health law is amended by adding a new paragraph (h) to read as follows:
- (H) DOCUMENTATION THAT THE PHYSICIAN HAS COMPLETED THE COURSE WORK OR TRAINING AS MANDATED BY SECTION SIX THOUSAND FIVE HUNDRED FIVE-D OF THE EDUCATION LAW. A HOSPITAL OR FACILITY SHALL NOT GRANT OR RENEW PROFESSIONAL PRIVILEGES OR ASSOCIATION TO A PHYSICIAN WHO HAS NOT COMPLETED SUCH COURSE WORK OR TRAINING.
- 17 S 3. This act shall take effect on the first of January next succeed18 ing the date on which it shall have become a law; provided that the
 19 commissioner of education is immediately authorized and directed to
 20 promulgate, amend and/or repeal any rules and regulations necessary to
 21 implement the provisions of this act on such effective date.
