Introduced by Sens. MONTGOMERY, HASSELL-THOMPSON, OPPENHEIMER -- read twice and ordered printed, and when printed to be committed to the Committee on Investigations and Government Operations

AN ACT to amend the tax law and the state finance law, in relation to providing a tax check-off box on personal income tax return forms for gifts to the school-based health centers fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The tax law is amended by adding a new section 630-c to  
2     read as follows:  
3     S 630-C. GIFT FOR SCHOOL-BASED HEALTH CENTERS. EFFECTIVE FOR ANY TAX  
4     YEAR COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND ELEVEN, AN INDI-  
5     VIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE SCHOOL-BASED  
6     HEALTH CENTERS FUND. SUCH CONTRIBUTION SHALL BE IN ANY WHOLE DOLLAR  
7     AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY SUCH INDI-  
8     VIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE PERSONAL INCOME TAX  
9     RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIBUTION. THE COMMISSIONER  
10    SHALL ALSO ENSURE THAT A DESCRIPTION OF A SCHOOL-BASED HEALTH CENTER IS  
11    INCLUDED WITHIN THE TAX FORM PREPARATION INSTRUCTION BOOKLET. NOTWITH-  
12    STANDING ANY OTHER PROVISION OF LAW ALL REVENUES COLLECTED PURSUANT TO  
13    THIS SECTION SHALL BE CREDITED TO THE SCHOOL-BASED HEALTH CENTERS FUND  
14    AND USED ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION EIGHTY-ONE OF THE  
15    STATE FINANCE LAW.  
16    S 2. The state finance law is amended by adding a new section 81 to  
17    read as follows:  
18    S 81. SCHOOL-BASED HEALTH CENTERS FUND. 1. THERE IS HEREBY ESTABLISHED  
19    IN THE JOINT CUSTODY OF THE COMPTROLLER AND THE COMMISSIONER OF HEALTH,  
20    A SPECIAL FUND TO BE KNOWN AS THE "SCHOOL-BASED HEALTH CENTERS FUND".  
21    2. SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED PURSUANT TO THE  
22    PROVISIONS OF SECTION SIX HUNDRED THIRTY-C OF THE TAX LAW, AND ALL OTHER

1 MONEYS APPROPRIATED, CREDITED, OR TRANSFERRED THERETO FROM ANY OTHER  
2 FUND OR SOURCE PURSUANT TO LAW. NOTHING CONTAINED HEREIN SHALL PREVENT  
3 THE STATE FROM RECEIVING GRANTS, GIFTS OR BEQUESTS FOR THE PURPOSES OF  
4 THE FUND AS DEFINED IN THIS SECTION AND DEPOSITING THEM INTO THE FUND  
5 ACCORDING TO LAW.

6 3. MONIES OF THE FUND SHALL BE EXPENDED TO FUND EXPANSION OF MEDICAL  
7 SERVICES AT EXISTING SCHOOL-BASED HEALTH CENTERS OR TO ESTABLISH NEW  
8 SCHOOL-BASED HEALTH CENTERS.

9 4. MONIES SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF  
10 THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMMISSIONER  
11 OF HEALTH.

12 5. AMOUNTS EXPENDED FOR SCHOOL-BASED HEALTH CENTERS PURSUANT TO THIS  
13 SECTION SHALL NOT AFFECT THE AMOUNT THAT WOULD OTHERWISE BE APPROPRIATED  
14 FOR SCHOOL-BASED HEALTH CENTERS UNDER ANY OTHER PROVISION OF LAW.

15 6. SERVICES PERFORMED BY SCHOOL-BASED HEALTH CENTERS AVAILABLE FOR  
16 MONEYS FROM THIS FUND SHALL INCLUDE, BUT NOT BE LIMITED TO:

17 A. COMPREHENSIVE PHYSICAL HEALTH AND MENTAL HEALTH ASSESSMENTS;

18 B. DIAGNOSIS AND TREATMENT OF ACUTE ILLNESSES;

19 C. VISION, HEARING, DENTAL, NUTRITIONAL, AND TUBERCULOSIS SCREENINGS;

20 D. ROUTINE MANAGEMENT OF CHRONIC DISEASES;

21 E. HEALTH EDUCATION;

22 F. MENTAL HEALTH COUNSELING AND REFERRALS;

23 G. IMMUNIZATIONS;

24 H. WORKING PAPERS AND SPORTS PHYSICALS; AND

25 I. POPULATION-BASED PRIMARY PREVENTION.

26 SERVICES SHALL BE PROVIDED ON-SITE BY A MULTI-DISCIPLINARY TEAM  
27 CONSISTING OF A MID-LEVEL PRACTITIONER, A MENTAL HEALTH COUNSELOR, AND A  
28 MEDICAL ASSISTANT IN CONSULTATION WITH A PHYSICIAN. THE CENTERS SHALL  
29 ALSO PROVIDE ACCESS TO HEALTH CARE TWENTY-FOUR HOURS PER DAY, SEVEN DAYS  
30 PER WEEK.

31 S 3. This act shall take effect immediately.
