AN ACT to authorize the city of New York to lease certain parkland in the borough of the Bronx to the New York Botanical Garden for a term of 99 years

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The city of New York, acting by and through the commissioner of parks and recreation of such city, is hereby authorized to lease the parkland, inclusive of any rights-of-way, described in section four of this act to the New York Botanical Garden for a term of ninety-nine years in exchange for an annual payment of one dollar per year and other valuable consideration and upon such other terms and conditions as may be agreed upon between the parties. The term of such lease shall commence within 3 years of the effective date of this act.

Notwithstanding any other provision of law, general, special or 10 local, the lease of the parkland, inclusive of any rights-of-way, 11 described in section four of this act to the New York Botanical Garden 12 shall not be subject to review and approval pursuant to sections 197-c and 197-d of the New York city charter.
