- AN ACT to amend the retirement and social security law, in relation to authorizing retired firefighters to be employed as instructor of fire sciences by a career and technical education center without diminution of his or her retirement benefits

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The retirement and social security law is amended by adding 2 a new section 214-c to read as follows:

3 214-C. EMPLOYMENT OF CERTAIN RETIRED PERSONS WHO RETIRED FROM FIRE S 4 NOTWITHSTANDING THE PROVISIONS OF THIS SERVICE. CHAPTER OR THE 5 OR LOCAL LAW OR CHARTER TO THE CONTRARY, NO PROVISIONS OF ANY STATE б RETIRED PERSON WHO RETIRED FROM FIRE SERVICE AS A MEMBER OF THE NEW YORK 7 STATE AND LOCAL POLICE AND FIRE RETIREMENT SYSTEM OR THE NEW YORK FIRE PENSION FUND, AND WHO IS EMPLOYED BY A CAREER AND TECHNICAL 8 DEPARTMENT 9 EDUCATION CENTER AS AN INSTRUCTOR IN A FIRE SCIENCE PROGRAM APPROVED BY EDUCATION DEPARTMENT, SHALL HAVE HIS OR HER RETIREMENT ALLOWANCE OR 10 THE 11 BENEFITS SUSPENDED OR REDUCED BECAUSE OF COMPENSATION EARNED ΒY SUCH RETIRED PERSON FROM SERVICE AS A FIRE SCIENCE INSTRUCTOR. 12

13 S 2. This act shall take effect immediately.

FISCAL NOTE.--This bill will allow retired firefighters of the New York State and Local Police and Fire Retirement System or the New York City Fire Department Pension Fund to work as a fire science instructor in a program approved by the New York State Department of Education and continue to receive their retirement benefit.
