AN ACT to amend the alcoholic beverage control law, in relation to authorizing the liquor authority to issue certain licenses to manufacture and sell alcoholic beverages in a premises commonly known as a restaurant-brewer

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 10 of section 64-c of the alcoholic beverage 2 control law, as added by chapter 538 of the laws of 1997, is amended to 3 read as follows:

- 10. (A) Except as provided in subdivisions seven, eight, nine, twelve, thirteen, fourteen and sixteen of this section, no person licensed under this section may be interested directly or indirectly in any other premises in this state where alcoholic beverages are manufactured or sold. Any person who has an interest in premises eligible for conversion under subdivision nine of this section shall not be issued any license under this section unless and until a conversion application has been filed with and approved by the authority.

- BEGINNING AT A POINT IN THE WEST LINE OF ELLICOTT STREET WHERE SAID WEST LINE IS INTERSECTED BY THE SOUTHERLY LINE OF SAID INNER LOT NO. 21 200, WHICH POINT IS ONE HUNDRED EIGHTY-NINE AND SIX TENTHS (189.60) FEET SOUTH OF THE INTERSECTION OF SAID WEST LINE OF ELLICOTT STREET WITH THE 23 SOUTH LINE OF HURON STREET; RUNNING THENCE WESTERLY ALONG THE SOUTH LINE
