AN ACT to amend the parks, recreation and historic preservation law, in relation to extending draft management plan submission dates and to amend chapter 595 of the laws of 2007 relating to establishing the Michigan Street African American Heritage Corridor commission in Buffalo, in relation to the effectiveness thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 2 of section 41.09 of the parks, recreation and  
2     historic preservation law, as amended by chapter 438 of the laws of  
3     2011, is amended to read as follows:  
4     2. The draft management plan shall be submitted to the commissioner  
5     for approval by [December thirty-first, two thousand eleven] JULY THIR-  
6     TY-FIRST, TWO THOUSAND THIRTEEN. Prior to submitting the plan to the  
7     commissioner, the legislative representative body of the city of Buffalo  
8     must approve the plan. The legislative body of the city of Buffalo, at  
9     its discretion and in the interest of expediting the local approval  
10    process, shall hold two public meetings at any time during the local  
11    approval process. The commissioner may approve the plan, may return the  
12    plan to the commission with recommendations for approval, or may reject  
13    the plan. A copy of the approved plan shall be provided to the governor,  
14    the temporary president of the senate and the speaker of the assembly.  
15    S 2. Section 3 of chapter 595 of the laws of 2007, relating to estab-  
16    lishing the Michigan Street African American Heritage Corridor commis-  
17    sion in Buffalo, is amended to read as follows:  
18    S 3. This act shall take effect immediately, provided that section two  
19    of this act shall expire and be deemed repealed [April 30] DECEMBER 31,  
20    [2012] 2013.  
21    S 3. This act shall take effect immediately, except that if this act  
22    shall have become a law on or after December 31, 2011 this act shall  
23    take effect immediately and shall be deemed to have been in full force
