AN ACT to amend the administrative code of the city of New York, in relation to requiring the sanitation department of the city of New York to provide owners, lessees or person in charge of a premises at which a violation of the city solid waste disposal law is alleged to have occurred with a photograph of the materials, condition or situation constituting the violation

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision d of section 16-324 of the administrative code
2 of the city of New York, as amended by local law number 34 of the city
3 of New York for the year 2010, is amended to read as follows:
4 d. Any notice of violation or notice of hearing for a violation issued
5 to the owner, net lessee or person in charge of a premises at which a
6 violation of this chapter or any rule promulgated pursuant thereto is
7 alleged to have occurred shall be served by delivering a copy of the
8 notice thereof at the address maintained in the records of the depart-
9 ment of housing preservation and development or the department of
10 finance. The notice of violation or notice of hearing may be served by
11 regular mail or in accordance with section one thousand forty-nine-a of
12 the charter. ANY NOTICE OF VIOLATION OR NOTICE OF HEARING FOR A
13 VIOLATION ISSUED TO THE OWNER, NET LESSEE OR PERSON IN CHARGE OF A PREM-
14 ISSES AT WHICH A VIOLATION OF THIS CHAPTER OR ANY RULE PROMULGATED PURSU-
15 ANT THERETO IS ALLEGED TO HAVE OCCURRED SHALL BE ACCOMPANIED BY A PHOTO-
16 GRAPH, TAKEN BY A UNIFORMED MEMBER OF THE DEPARTMENT OF SANITATION, OF
17 THE MATERIALS, CONDITION OR SITUATION CONSTITUTING THE ALLEGED
18 VIOLATION. A COPY OF THE PHOTOGRAPH SHALL BE EITHER: 1. PRINTED WITH
19 THE TICKET AT THE TIME THE TICKET IS ISSUED; OR 2. ACCESSIBLE ONLINE AT
