AN ACT to amend the vehicle and traffic law and the executive law, in relation to enabling veterans to receive benefit information upon applying for or renewing a driver's license

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 1 of section 502 of the vehicle and traffic law, as amended by section 2 of part CC of chapter 58 of the laws of 2011, is amended to read as follows:

1. Application for license. Application for a driver's license shall be made to the commissioner. The fee prescribed by law may be submitted 5 with such application. The applicant shall furnish such proof of identity, age, and fitness as may be required by the commissioner. The commissioner may also provide that the application procedure shall include the 8 9 a photo image or images of the applicant in accordance with 10 rules and regulations prescribed by the commissioner. In addition, commissioner also shall require that the applicant provide his or her 11 social security number and provide space on the application so that the 12 13 applicant may register in the New York state organ and tissue donor registry under section forty-three hundred ten of the public health law. 14 IN ADDITION, THE COMMISSIONER SHALL ENSURE THAT SPACE IS PROVIDED ON THE 15 APPLICATION TO ENABLE ANY APPLICANT WHO IS A VETERAN OF THE MILITARY 16 NAVAL SERVICE OF THE UNITED STATES TO REGISTER TO RECEIVE INFORMATION 17 18 FROM THE DIVISION OF VETERANS' AFFAIRS BY EMAIL OR TELEPHONE 19 BENEFITS TO WHICH SUCH APPLICANT MAY BE ENTITLED AND THAT THE FOLLOWING 20 IS STATED ON THE APPLICATION: "BY CHECKING THIS BOX, YOU CERTIFY 21 YOU ARE A VETERAN OF THE MILITARY OR NAVAL SERVICE OF THE UNITED STATES AND YOU GIVE PERMISSION TO THE DEPARTMENT OF 22 MOTOR VEHICLES YOUR NAME AND CONTACT INFORMATION WITH THE DIVISION OF VETERANS' AFFAIRS 23 24 ENABLE THE DIVISION OF VETERANS' AFFAIRS TO CONTACT YOU VIA EMAIL OR TELEPHONE REGARDING BENEFITS TO WHICH YOU MAY BE ENTITLED". In addition, 26 an applicant for a commercial driver's license who will operate a commercial motor vehicle in interstate commerce shall certify that such 27

applicant meets the requirements to operate a commercial motor vehicle, set forth in public law 99-570, title XII, and title 49 of the code 3 of federal regulations, and all regulations promulgated by the United States secretary of transportation under the hazardous materials trans-5 portation act. In addition, an applicant for a commercial driver's 6 license shall submit a medical certificate at such intervals as required 7 the federal motor carrier safety improvement act of 1999 and Part 8 383.71(h) of title 49 of the code of federal regulations relating to medical certification and in a manner prescribed by the commissioner. 9 10 For purposes of this section and sections five hundred three and five hundred ten-a of this title, the term "medical certificate" shall mean a 11 form substantially in compliance with the form set forth in Part 391.43(h) of title 49 of the code of federal regulations. Upon a deter-12 13 14 mination that the holder of a commercial driver's license has made any 15 false statement, with respect to the application for such license, 16 commissioner shall revoke such license.

- S 2. Paragraph (a) of subdivision 6 of section 502 of the vehicle and traffic law, as amended by section 3 of part K of chapter 59 of the laws of 2009, is amended to read as follows:
- (a) A license issued pursuant to subdivision five of this shall be valid until the expiration date contained thereon, unless such license is suspended, revoked or cancelled. Such license may be renewed submission of an application for renewal, the fee prescribed by law, proofs of prior licensing, fitness and acceptable vision prescribed by the commissioner, the applicant's social security number, and if required by the commissioner a photo image of the applicant numbers and form as the commissioner shall prescribe. IN ADDITION, THE COMMISSIONER SHALL ENSURE THAT SPACE IS PROVIDED ON THE APPLICATION FOR RENEWAL TO ENABLE ANY APPLICANT WHO IS A VETERAN OF THE MILITARY OR NAVAL SERVICE OF THE UNITED STATES TO REGISTER TO RECEIVE INFORMATION THE DIVISION OF VETERANS' AFFAIRS BY EMAIL OR TELEPHONE REGARDING BENEFITS TO WHICH SUCH APPLICANT MAY BE ENTITLED AND THAT THE FOLLOWING APPLICATION FOR RENEWAL: "BY CHECKING THIS BOX, YOU THECERTIFY THAT YOU ARE A VETERAN OF THE MILITARY OR NAVAL SERVICE OF AND YOU GIVE PERMISSION TO THE DEPARTMENT OF MOTOR VEHI-STATES CLES TO SHARE YOUR NAME AND CONTACT INFORMATION WITH THE DIVISION OF VETERANS' AFFAIRS TO ENABLE THE DIVISION OF VETERANS' AFFAIRS TO CONTACT VIA EMAIL OR TELEPHONE REGARDING BENEFITS TO WHICH YOU MAY BE ENTI-TLED". In addition, an applicant for renewal of a license containing a hazardous material endorsement shall pass an examination to retain such endorsement. The commissioner shall, with respect to the renewal of a hazardous materials endorsement, comply with the requirements imposed upon states by sections 383.141 and 1572.13 of title 49 of the code of federal regulations. A renewal of such license shall be issued by the commissioner upon approval of such application, except that no such license shall be issued if its issuance would be inconsistent with the provisions of section five hundred sixteen of this title, and except that the commissioner may refuse to renew such license if the applicant is the holder of a currently valid or renewable license to drive issued by another state or foreign country unless the applicant surrenders such license.
  - S 3. Section 508 of the vehicle and traffic law is amended by adding a new subdivision 6 to read as follows:
- 6. THE COMMISSIONER SHALL APPOINT AGENTS TO ACT ON HIS OR HER BEHALF TO COLLECT, STORE AND MAKE AVAILABLE TO THE DIVISION OF VETERANS' AFFAIRS THE NAME AND CONTACT INFORMATION OF A VETERAN APPLICANT WHO

1 REQUESTS TO RECEIVE BENEFIT INFORMATION FROM THE DIVISION OF VETERANS' 2 AFFAIRS PURSUANT TO SUBDIVISION ONE OR PARAGRAPH (A) OF SUBDIVISION SIX 3 OF SECTION FIVE HUNDRED TWO OF THIS ARTICLE.

- 4 S 4. Section 353 of the executive law is amended by adding a new 5 subdivision 21 to read as follows:
- 21. TO COORDINATE WITH THE DEPARTMENT OF MOTOR VEHICLES PURSUANT TO SUBDIVISION ONE OR PARAGRAPH (A) OF SUBDIVISION SIX OF SECTION FIVE HUNDRED TWO OF THE VEHICLE AND TRAFFIC LAW TO RETRIEVE NAME AND CONTACT INFORMATION OF VETERANS WHO ARE APPLYING FOR OR RENEWING THEIR DRIVER'S LICENSES AND WHO REQUEST TO BE CONTACTED BY THE DIVISION VIA EMAIL OR TELEPHONE REGARDING BENEFITS TO WHICH THEY MAY BE ENTITLED.
- 12 S 5. This act shall take effect immediately.
