AN ACT to amend the general business law and the penal law, in relation to establishing jurisdiction and venue for a pattern of criminal offenses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The general business law is amended by adding a new section 527 to read as follows:

- S 527. JURISDICTION AND VENUE FOR A PATTERN OF CRIMINAL OFFENSE. PERSON MAY BE PROSECUTED FOR CRIMINAL ACTIONS WITH RESPECT TO EACH OF THE ALLEGED CRIMINAL OFFENSES INCLUDED WITHIN A PATTERN OF CRIMINAL OFFENSES THAT ARE PART OF THE SAME PLAN, SCHEME, OR ADVENTURE OF ORGAN-IZED RETAIL CRIME, IN ANY COUNTY WHERE AT LEAST ONE ALLEGED OFFENSE HAS OCCURRED AND SUCH OFFENSE IS PART OF THE ALLEGED PATTERN OF CRIMINAL ACTIVITY. ONE DISTRICT COURT MAY POSSESS JURISDICTION OVER CRIMINAL OFFENSES, PERSONS AND PROPERTY THAT ARE PART OF, OR ARE DIRECT-RELATED TO, EACH OR ALL OF THE ALLEGED CRIMINAL OFFENSES FORMING THE ALLEGED PATTERN OF CRIMINAL OFFENSES OF ORGANIZED RETAIL CRIME.

- 16 S 2. The penal law is amended by adding a new section 70.16 to read as follows: 17
- 18 S 70.16 JURISDICTION AND VENUE FOR A PATTERN OF CRIMINAL OFFENSE.

A PERSON MAY BE PROSECUTED FOR CRIMINAL ACTIONS WITH RESPECT 20 EACH OF THE ALLEGED CRIMINAL OFFENSES INCLUDED WITHIN A PATTERN OF CRIM-THAT ARE PART OF THE SAME PLAN, SCHEME, OR ADVENTURE, IN 21 INAL OFFENSES ANY COUNTY WHERE AT LEAST ONE ALLEGED CRIMINAL OFFENSE HAS OCCURRED AND 22 IS PART OF THE ALLEGED PATTERN OF CRIMINAL ACTIVITY. ONE 23 SUCH OFFENSE
- 24 DISTRICT COURT MAY POSSESS JURISDICTION OVER ALL CRIMINAL OFFENSES, PERSONS AND PROPERTY THAT ARE PART OF, OR ARE DIRECTLY RELATED TO, EACH
- 26 OR ALL OF THE ALLEGED CRIMINAL OFFENSES FORMING THE ALLEGED PATTERN OF CRIMINAL OFFENSES. 27

2. THIS SECTION SHALL BE ENFORCED IN ANY COUNTY WHERE AT LEAST ONE ALLEGED CRIMINAL OFFENSE HAS OCCURRED AND SUCH OFFENSE IS PART OF THE ALLEGED PATTERN OF CRIMINAL ACTIVITY.

S 3. This act shall take effect on the first of November next succeeding the date on which it shall have become a law.
