- AN ACT to amend the tax law, in relation to the allocation of credit for the empire state film production credit; and to repeal section 7 of part P of chapter 60 of the laws of 2004, amending the tax law relating to the empire state film production credit, relating thereto

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 7 of part P of chapter 60 of the laws of 2004, 2 amending the tax law relating to the empire state film production cred-3 it, is REPEALED.

4 S 2. Section 24 of the tax law is amended by adding a new subdivision 5 (e) to read as follows:

6 (E) ALLOCATION OF CREDIT. THE AGGREGATE AMOUNT OF TAX CREDITS (1) THIRTY-SIX OF SECTION 7 ALLOWED UNDER THIS SECTION, SUBDIVISION TWO 8 HUNDRED TEN AND SUBSECTION (GG) OF SECTION SIX HUNDRED SIX OF THIS CHAP-9 IN ANY CALENDAR YEAR SHALL BE TWENTY-FIVE MILLION DOLLARS IN TWO TER THOUSAND FOUR AND TWO THOUSAND FIVE, SIXTY MILLION DOLLARS IN TWO 10 THOU-SAND SIX AND TWO THOUSAND SEVEN, SIXTY-FIVE MILLION DOLLARS IN TWO THOU-11 12 SAND EIGHT, SEVENTY-FIVE MILLION DOLLARS INTWO THOUSAND NINE, 13 EIGHTY-FIVE MILLION DOLLARS IN TWO THOUSAND TEN, NINETY MILLION DOLLARS 14 TWO THOUSAND ELEVEN AND TWO THOUSAND TWELVE, AND ONE HUNDRED TEN IN MILLION DOLLARS IN TWO THOUSAND THIRTEEN. SUCH AGGREGATE AMOUNT OF CRED-15 16 ITS SHALL BE ALLOCATED BY THE GOVERNOR'S OFFICE FOR MOTION PICTURE AND 17 TELEVISION DEVELOPMENT AMONG TAXPAYERS IN ORDER OF PRIORITY BASED UPON 18 THE DATE OF FILING AN APPLICATION FOR ALLOCATION OF FILM PRODUCTION 19 CREDIT WITH SUCH OFFICE. ΙF THE TOTAL AMOUNT OF ALLOCATED CREDITS APPLIED FOR IN ANY PARTICULAR YEAR EXCEEDS THE AGGREGATE AMOUNT 20 OF TAX ALLOWED FOR SUCH YEAR UNDER THIS SECTION, SUCH EXCESS SHALL BE 21 CREDITS 22 TREATED AS HAVING BEEN APPLIED FOR ON THE FIRST DAY OF THE SUBSEQUENT 23 YEAR.

CHAPTER IN ANY CALENDAR YEAR SHALL BE TWELVE MILLION FIVE HUNDRED THOU-1 SAND DOLLARS IN TWO THOUSAND FOUR AND TWO THOUSAND FIVE AND THIRTY 2 3 MILLION DOLLARS IN TWO THOUSAND SIX THROUGH TWO THOUSAND ELEVEN. (3) ADDITIONAL POOL 1 - THE AGGREGATE AMOUNT OF TAX CREDITS ALLOWED IN
SUBDIVISION (A) OF THIS SECTION SHALL BE INCREASED BY AN ADDITIONAL
THREE HUNDRED FIFTY MILLION DOLLARS IN TWO THOUSAND NINE. THIS ADDITIONAL AMOUNT SHALL BE ALLOCATED BY THE GOVERNOR'S OFFICE FOR MOTION
PICTURE AND TELEVISION DEVELOPMENT AMONG TAXPAYERS IN ACCORDANCE WITH
SUBDIVISION (A) OF THIS SECTION.

(4) ADDITIONAL POOL 2 - THE AGGREGATE AMOUNT OF TAX CREDITS ALLOWED IN 18 19 SUBDIVISION (A) OF THIS SECTION SHALL BE INCREASED BY AN ADDITION FOUR 20 HUNDRED TWENTY MILLION DOLLARS IN TWO THOUSAND TEN, FOUR HUNDRED TWENTY 21 MILLION DOLLARS IN TWO THOUSAND ELEVEN, FOUR HUNDRED TWENTY MILLION DOLLARS IN TWO THOUSAND TWELVE, FOUR HUNDRED TWENTY MILLION DOLLARS 22 IN TWO THOUSAND THIRTEEN AND FOUR HUNDRED TWENTY MILLION DOLLARS IN TWO 23 THOUSAND FOURTEEN PROVIDED HOWEVER, SEVEN MILLION DOLLARS OF THE ANNUAL 24 25 ALLOCATION SHALL BE AVAILABLE FOR THE EMPIRE STATE FILM POST PRODUCTION CREDIT PURSUANT TO SECTION THIRTY-ONE OF THIS CHAPTER AND SUCH 26 SEVEN MILLION DOLLARS SHALL BE REGIONALLY ALLOCATED IN THE SAME MANNER AS 27 SUBPARAGRAPHS (I), (II) AND (III) OF PARAGRAPH TWO OF SUBSECTION (A) OF 28 SECTION TWENTY-EIGHT OF THIS ARTICLE. TAXPAYERS ELIGIBLE TO CLAIM A CREDIT MUST REPORT THE ALLOCATION YEAR DIRECTLY ON THEIR EMPIRE 46 STATE FILM PRODUCTION CREDIT TAX FORM FOR EACH YEAR A CREDIT IS CLAIMED 47 AND INCLUDE A COPY OF THE CERTIFICATE WITH THEIR TAX RETURN. IN THE CASE 48 49 OF A QUALIFIED FILM THAT RECEIVES FUNDS FROM ADDITIONAL POOL 2, NO EMPIRE STATE FILM PRODUCTION CREDIT SHALL BE CLAIMED BEFORE THE LATER OF 50 THE TAXABLE YEAR THE PRODUCTION OF THE OUALIFIED FILM IS COMPLETE, OR 51 THE TAXABLE YEAR IMMEDIATELY FOLLOWING THE ALLOCATION YEAR FOR WHICH THE 52 FILM HAS BEEN ALLOCATED CREDIT BY THE GOVERNOR'S OFFICE FOR MOTION 53 PICTURE AND TELEVISION DEVELOPMENT. 54

3 laws of 2010, are amended to read as follows: 4 (2) The amount of the credit shall be the product (or pro rata share 5 of the product, in the case of a member of a partnership) of [ten] TWEN-6 TY percent and the qualified post production costs paid in the 7 production of a qualified film at a qualified post production facility.

8 (c) Notwithstanding any other provision of law to the contrary, the aggregate amount of tax credits available under this section shall not 9 10 exceed the amounts allowed pursuant to PARAGRAPH FOUR OF subdivision (e) of section [seven of part P of chapter sixty of the laws of two thousand 11 four] TWENTY-FOUR OF THIS ARTICLE and shall be allocated in the same 12 manner as provided for in PARAGRAPH ONE OF subdivision [(a)] (E) of 13 14 section [seven of part P of chapter sixty of the laws of two thousand four] TWENTY-FOUR OF THIS ARTICLE. 15
