AN ACT to amend the general municipal law and the administrative code of the city of New York, in relation to service by police officers in a narcotics unit

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The general municipal law is amended by adding a new 2 section 208-h to read as follows:
- S 208-H. SERVICE IN A NARCOTICS UNIT; LIMITATION. NOTWITHSTANDING THE OF ANY GENERAL, SPECIAL OR LOCAL LAW OR ANY RULE OR REGU-PROVISIONS LATION OF ANY POLICE DEPARTMENT OR COMMISSIONER OR 5 HEAD THEREOF, A 6 OF A POLICE FORCE, INCLUDING POLICE DETECTIVES, SHALL NOT BE 7 REQUIRED TO BE ASSIGNED TO THE NARCOTICS UNIT OF SUCH POLICE DEPARTMENT 8 FOR A PERIOD OF TIME WHICH EXCEEDS THIRTY-SIX MONTHS. SUCH TIME LIMIT 9 SHALL BE THE AGGREGATE OF ALL SERVICE UNDER ANY TITLE, POSITION OR 10 APPOINTMENT.
- 11 S 2. The administrative code of the city of New York is amended by 12 adding a new section 14-117.1 to read as follows:
- 13 S 14-117.1 SERVICE IN A NARCOTICS UNIT; LIMITATION. NOTWITHSTANDING 14 ANY INCONSISTENT PROVISION OF LAW, RULE OR REGULATION OF THE DEPARTMENT
- 15 OR THE COMMISSIONER, A MEMBER OF THE POLICE FORCE, INCLUDING POLICE
- 16 DETECTIVES, SHALL NOT BE REQUIRED TO BE ASSIGNED TO THE NARCOTICS UNIT 17 OF SUCH POLICE DEPARTMENT FOR A PERIOD OF TIME WHICH EXCEEDS THIRTY-SIX
- 18 MONTHS. SUCH TIME LIMIT SHALL BE THE AGGREGATE OF ALL SERVICE UNDER ANY
- 19 TITLE, POSITION OR APPOINTMENT.
- 20 S 3. This act shall take effect immediately.
