AN ACT to amend the tax law, in relation to granting a deduction in personal income tax for home security expenses

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Subsection (d) of section 615 of the tax law is amended by adding a new paragraph 5 to read as follows:
- 3 (5) AN AMOUNT, NOT EXCEEDING FIVE HUNDRED DOLLARS IN THE AGGREGATE, 4 FOR THE EXPENSES INCURRED BY A TAXPAYER WHO IS OWNER OCCUPANT OF A ONE, 5 TWO, OR THREE FAMILY HOME FOR PROVIDING SECURITY FOR HIS OR HER HOME 6 INCLUDING, BUT NOT LIMITED TO, EXTERIOR LIGHTING, BURGLAR AND FIRE 7 ALARMS.
- 8 S 2. This act shall take effect immediately.
