AN ACT to amend the real property actions and proceedings law, in relation to grounds for bringing a special proceeding, and payment to and liability of administrators appointed pursuant to a special proceeding

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 1 of section 770 of the real property actions
2 and proceedings law, as amended by chapter 877 of the laws of 1982, is
3 amended to read as follows:
4 1. One-third or more of the tenants occupying a dwelling located in
5 the city of New York or the commissioner of the department of the city
6 of New York charged with enforcement of the housing maintenance code of
7 such city, or in the counties of Nassau, Suffolk, Rockland and Westches-
8 ter may maintain a special proceeding as provided in this article, upon
9 the ground that there exists in such dwellings or in any part thereof a
10 lack of heat or of running water or of light or of electricity or of
11 adequate sewage disposal facilities, or any other condition dangerous to
12 life, health or safety, which has existed for five days, or an infesta-
13 tion by rodents, or any combination of such conditions; or course of
14 conduct by the owner or [his] THE OWNER'S agents of harassment, illegal
15 eviction, continued deprivation of services or other acts dangerous to
16 life, health or safety, OR THE ISSUANCE OF AN ORDER TO THE OWNER OF SUCH
17 DWELLING BY THE COMMISSIONER OF SUCH DEPARTMENT OF THE CITY OF NEW YORK
18 PURSUANT TO THE ALTERNATIVE ENFORCEMENT PROGRAM UNDER SECTION 27-2153 OF

1 THE ADMINISTRATIVE CODE OF THE CITY OF NEW YORK, PROVIDED THAT SUCH
2 DWELLING HAS NOT BEEN DISCHARGED FROM THE PROGRAM PURSUANT TO SUCH
3 SECTION AND THERE HAS NOT BEEN A DETERMINATION THAT THE OWNER HAS
4 SUBSTANTIALLY COMPLIED WITH SUCH ORDER.

5 S 2. Subdivision 1 of section 778 of the real property actions and
6 proceedings law, as amended by chapter 95 of the laws of 1989, is
7 amended to read as follows:

8 1. The court is authorized and empowered, in implementation of a judg-
9 ment rendered pursuant to section seven hundred seventy-six or seven
10 hundred seventy-seven of this article, to appoint a person other than
11 the owner, a mortgagee or lienor, to receive and administer the rent
12 moneys or security deposited with [him] SUCH OWNER, MORTGAGEE OR LIENOR,
13 subject to the court's direction. The court may appoint the commissioner
14 of the department of the city of New York charged with enforcement of
15 the housing maintenance code of such city or [his] THE COMMISSIONER'S
16 designee as such administrator, provided that [he] THE COMMISSIONER OR
17 THE COMMISSIONER'S DESIGNEE shall consent, in writing, to such appoint-
18 ment. Any administrator is authorized and empowered in accordance with
19 the direction of the court, to order the necessary materials, labor and
20 services to remove or remedy the conditions specified in the judgment,
21 and to make disbursements in payment thereof; and to demand, collect and
22 receive the rents from the tenants; and to institute all necessary legal
23 proceedings including, but not limited to, summary proceedings for the
24 removal of any tenant or tenants; and to rent or lease for terms not
25 exceeding three years any part of said premises, however, the court may
26 direct the administrator to rent or lease commercial parts of said prem-
27 ises for terms that the court may approve. In addition, such administra-
28 tor is authorized and empowered in accordance with the direction of the
29 court to accept and repay such moneys as may be received from the
30 department charged with enforcement of the housing maintenance code of
31 the city of New York for the purpose of replacing or substantially reha-
32 bilitating systems or making other repairs or capital improvements
33 authorized by the court. All moneys expended by the department pursuant
34 to the foregoing shall constitute a debt recoverable from the owner and
35 a lien upon the building and lot, and upon the rents and other income
36 thereof. Such lien shall be enforced in accordance with the provisions
37 of article eight of subchapter five of the housing maintenance code of
38 the city of New York. Such administrator, shall, upon completion of the
39 work prescribed in such judgment, file with the court a full accounting
40 of all receipts and expenditures for such work. Such administrator shall
41 dispose of the rents and other monies deposited with [him] SUCH ADMINIS-
42 TRATOR according to the following order of priority:

43 (a) Payment in full for all of the work specified in the judgment.
44 Until all of the work specified in the judgment has been completed and
45 payment for such work has been made, no other disbursements shall be
46 permitted, except for fuel bills, fire and liability insurance, and
47 bills for ordinary repairs and maintenance.

48 (b) Payment of a reasonable amount for the services of such adminis-
49 trator, INCLUDING REIMBURSEMENT OF ANY LEGAL FEES INCURRED BY SUCH
50 ADMINISTRATOR IN CONNECTION WITH MANAGEMENT OF THE BUILDING.

51 (c) Payment of outstanding real property tax liens claimed by the city
52 of New York.

53 (d) Payment of outstanding emergency repair liens filed and recorded
54 by the city of New York and outstanding liens filed and recorded by the
55 city pursuant to this section.

1 (e) Payment to the owner of any surplus remaining after payments of
2 paragraphs (a) through (d) of this subdivision have been made.

3 S 3. Subdivision 6 of section 778 of the real property actions and
4 proceedings law, as added by chapter 877 of the laws of 1982, is amended
5 to read as follows:

6 6. Such administrator shall be liable only in his OR HER official
7 capacity for injury to persons and property by reason of conditions of
8 the premises in a case where an owner would have been liable; he OR SHE
9 shall not have any liability in his OR HER personal capacity. APPOINT-
10 MENT OF AN ADMINISTRATOR PURSUANT TO SUBDIVISION ONE OF THIS SECTION
11 SHALL NOT RELIEVE AN OWNER OF LIABILITY FOR INJURY TO PERSONS AND PROP-
12 ERTY IN SUCH CASE.

13 S 4. Section 778 of the real property actions and proceedings law is
14 amended by adding a new subdivision 11 to read as follows:

15 11. THE COURT MAY ONLY DISCHARGE AN ADMINISTRATOR IF THE OWNER HAS
16 PAID IN FULL OR ENTERED INTO A PAYMENT AGREEMENT TO PAY IN FULL ALL
17 OUTSTANDING REAL PROPERTY TAX LIENS CLAIMED BY THE CITY OF NEW YORK, ALL
18 OUTSTANDING EMERGENCY REPAIR LIENS FILED AND RECORDED BY THE CITY OF NEW
19 YORK, ALL OUTSTANDING CHARGES AND LIENS ASSESSED IN CONNECTION TO THE
20 ALTERNATIVE ENFORCEMENT PROGRAM AUTHORIZED BY SECTION 27-2153 OF THE
21 ADMINISTRATIVE CODE OF THE CITY OF NEW YORK, AND OUTSTANDING LIENS FILED
22 AND RECORDED BY THE CITY PURSUANT TO THIS SECTION. THE PROVISIONS OF
23 THIS SUBDIVISION SHALL NOT APPLY TO BUILDINGS TRANSFERRED PURSUANT TO
24 SUBDIVISION TEN OF THIS SECTION.

25 S 5. This act shall take effect immediately.
