WHEREAS, A Nassau County native, Stephen W. Schlissel is a graduate of the Wharton School of the University of Pennsylvania, and Harvard Law School, cum laude; and

WHEREAS, For 34 years, Stephen W. Schlissel taught as an adjunct professor at Brooklyn Law School, and for 20 years, he was an adjunct professor at Hofstra Law School; and

WHEREAS, Stephen W. Schlissel is a founding and the managing member of Schlissel Ostrow Karabatos, PLLC of Garden City, Long Island, New York; he is also a co-founder of P.E.A.C.E. (Parent Education And Custody Effectiveness) which established a program for educating parents and children in divorce situations; and

WHEREAS, He served as co-Chair of a National Joint Task Force of the American Bar Association's Family Law Section, and the Association of Family and Conciliatory Courts, which had the goal of establishing standards and models for Parent Education Programs in other localities; and

WHEREAS, Stephen W. Schlissel was chosen as one of the top attorneys in the United States in all editions of THE BEST LAWYERS IN AMERICA (Woodward/Whitel), only one of less than 250 family law attorneys to be so chosen; and

WHEREAS, Continuously designated a "Super Lawyer", in 2010, Stephen W. Schlissel was selected as one of the top 100 Super Lawyers, out of 65,000, in the New York City Metropolitan area; and
