WHEREAS, Paul Marius Beer, M.D. received his Bachelor's degree from Columbia University and his Medical degree from SUNY Stony Brook; in 1986, he received a fellowship at the Louisiana State University Eye Center where he specialized in diseases and surgery of the retina and vitreous; and

WHEREAS, Following his faculty teaching positions at Columbia University and Albany Medical College, Paul Marius Beer, M.D. was Professor of Ophthalmology and Director of the Retina Division at Albany Medical College; and

WHEREAS, Throughout the entire period of his professional and community service, a period of constructive involvement, Paul Marius Beer, M.D. has stood constant in dignity, good grace and humor; and

WHEREAS, Rare indeed is the impressive dedication shown by an individual for the benefit of others which Paul Marius Beer, M.D. has displayed throughout his life; and
